Order

Ms. G. Esther Rani has filed complaint dated **13-11-2019** which was received by this Commission on **13-11-2019** for not getting the information sought by him from the Public Information Officer/ O/o the GM (PER), SCCL., Kothagudem, Bhadradi – Kothagudem District.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **28-01-2019** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

Under :-

1. I have represented to the Hon'ble District collector Bhadradi kothagudem on 13-11-2018 which is forwarded to your office for take necessary action vide file no. RC.No. 44/3350/2018 dt 08/01/2019. Hence kindly to provide complete information which your office had taken action in the said matter from the date of receipt.
2. I have lodged complaint to the Hon'ble Governor on 31-07-2017, 28-08-2017 and 16-11-2017 which was forwarded to your office on 4-1-2018 vide file no. 15051/1926/T2/S/2017. Therefore kindly to provide complete information in the said file from the date of receipt. And may be provide all documents status of the matter as by you.
3. I have lodged complaint against Narsimha Warden to your office on 24/02/2013. Hence kindly to provide complete information and all documents status of my complaint which was taken against action on my complaint.
4. I have lodged complaint to the Hon'ble S.I. J. Rambhadr Kumar I.S. against Mr. Ramnarayana and Head Master on 12/10/2014. Therefore kindly to provide all documents and which you had taken action against above said persons on my complaint and may be provide status of my complaint. I have affixed court fee RS 10/- and I will be pay the cost of the photocopy of the documents which may be needed by you.

The Public Information Officer through Ref. No. CRP/RTI-PIO/GC/127 dated 31-01-2019 informed to the complainant that their office gives information related to SCCL corporate & Hyd Areas only. Hence, it is requested to obtain the informed from concerned PIOs.

Stating that the complainant was not satisfied with the reply of the Public Information Officer, she preferred this complaint before the Commission requesting to arrange to furnish the information sought by her u/s 18(1) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing on **19-04-2021 at 10.30 AM.**

The Case was heard on 19-04-2021. The complainant was present and submitted that the PIO has rejected her application. The PIO/ Sri.D.Srinivas, Deputy General Manager(Personnel), O/o.SCCL, Kothagudem, Bhadradi Kothagudem District was present and stated before the Commission that the information sought by the complainant does not come under the definition of information as per section 2(j) of the RTI Act and also vide letter Ref.No.CRP/RTI-PIO/GC/127, dated.31-01-2019 they have informed the appellant that the information pertains to SCCL, corporate & Hyderabad Areas to the complainant through registered post. The PIO further submitted a copy of the letter before the Commission.

Heard the PIO and perused the material papers available on records. The Commission observed that the information sought by the complainant does not attracts to definition of information u/s.2(j) of the RTI Act 2005 hence the PIO has rejected the same.

In view of the above, the complaint is closed.
