Order

Sri P. Prashanth has filed second appeal dated **15-11-2019** which was received by this Commission on **15-11-2019** for not getting the information sought by him from the Public Information Officer/ O/o the Osmania Hospital, Hyderabad and the First Appellate Authority/ O/o the Director of Medical Education, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **25-07-2019** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

- 1) Name of the contractor ,tender details, amount received from telangana government since 17 months and its Xerox copies
- 2) Tender call for notifications in press & contract orders from the government/superintendent provide certified copies.
- 3) How many employees are working in SANITATION in OSMANIA hospital, and there attendance and payment details and account statement ,cash book details and biometric attendance when and what time there salary deposited with xerox copies.
- 4) The salaries of employees hiked by government from which date did the contractor paid them and regarding there provident fund details of the employees its details & xerox copies of it
- 5) Work done by Sanitation employees by contractor in OSMANIA hospital daily and there reports from each department attested copies by the incharges and log book Xerox for 17 months
- 6) Name of the SANITATION incharge his designation and his duties.
- 7) How many times the cleaning with antiseptic lotions/mopping in the hospital premises in Emergency ICU's / Theatres / wards give the complete details & attested copies of concerned RMO'S for 17 months.
- 8) What is the antiseptic lotions used in the hospital whether is it using or not give the certified copies from the HOD's of the concerned departments of the hospital.
- 9) How are these employees of sanitation are getting salaries from contractor is it deposited in their bank accounts directly or by cash, please give the details of each employee for last 2 year

Stating that the appellant did not get any response from the Public Information Officer, he filed 1st appeal dated **04-09-2019** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

The First Appellate Authority through Lr.Rc.No. 387633 to677/2019 dated 14-09-2019 requested the Public Information Officer/ Osmania General Hospital and the Public Information Officer/ Gandhi Hospital to provide the point wise information directly to the applicant.

Stating that the appellant was not satisfied with the reply of the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

The Public Information Officer/ Osmania Hospital, Hyderabad through Letter dated 28-01-2020 informed to the Commission that the available information was furnished to the appellant.

In view of the above, with a request to both the parties to attend for hearing on **20-04-2019 at 10.30 AM.**

The Case was heard on 20-04-2021. The appellant was present and submitted that the PIO has not provided complete information. The PIO/ Dr.T.Sai Shobha, DCS.RMO, Osmania Hospital, Hyderabad was present and stated that vide letter Rc.No.41/PIO/Qtr-3rd/RTI-Act-2005/OGH/2019/140, dated. 28-01-2020 part information has been furnished to the appellant. The PIO further submitted a copy of the information before the Commission.

The Commission directs the PIO to furnish the remaining information to the appellant within one week through registered post with acknowledgement due and to report compliance the Commission.

With the above direction, the appeal is closed.
