Order

Sri.Sambasivaw Rao has filed complaint dated **05-02-2019** which was received by this Commission on **05-02-2019** for not getting the information sought by him from the Public Information Officer/ The GM (PER), Welfare & CSR, O/o the SCCL., Kothagudem, Bhadradi – Kothagudem District.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **24-11-2019** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

- ① Since 1998 to 31-10-2017, the refused medical claims of thousands of employees of SCCL who undertook out-side operations.
- ② The list of Officers/NCWA employees of SCCL whose medical claims were paid, who are referred or who had intimated after joined in the hospital to procedure.
- ③ The procedure, competent authority to refer out-side Hospitals, to pay or refuse medical claim, circulars/Agreements.
- ④ The all documents, from AWS, SRD, SCCL refusal letter to Medical Claim sent, workmen representatives, copies of MV-N.R. Prasad, G. Hoz. AWS, SRD, EC No 2988351.
- ⑤ The Medical Attendance Rules / policy of employee of SCCL. The Note-File, endorsements, not to paid medical claim.

Stating that the complainant did not get any response from the Public Information Officer, he preferred this complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing on **19-04-2021 at 10.30 AM.**

The Case was heard on 19-04-2021. The complainant was present and submitted that the PIO has provided only part information. The PIO/ Sri.D.Srinivas, Deputy General Manager(Personnel), O/o.SCCL, Kothagudem, Bhadradri Kothagudem District was present and stated before the Commission that vide letter Ref.No.CRP/RTI-PIO/2420/84, dated.27-01-2018 the information sought by the complainant is furnished through registered post. The PIO further submitted a copy of the information along with the copy of the acknowledgement.

Heard both the parties and perused the material papers available on records. The Commission observed that the PIO has furnished the information to the appellant but the appellant claims that he has received only part information.

Hence the Commission directs the PIO to furnish the complete information to the complainant within one week through Registered post with acknowledgment due.

With the above direction, the complaint is closed.
