

## Order

Sri V. Kanthaiah has filed second appeal dated **25-10-2018** which was received by this Commission on **25-10-2018** for not getting the information sought by him from the Public Information Officer/ O/o the Deputy Commissioner, GHMC., Circle-21, Chandanagar, Ranga Reddy District and the First Appellate Authority/ O/o the Zonal Commissioner, Serilingampally Zone, Ranga Reddy District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **14-05-2018** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:



The Public Information Officer through Letter dated 29-05-2018 informed to the appellant that the search has been made in the record section and observed that the said information is not available. Therefore the appellant has to furnish the details to HMDA & DTCP.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1<sup>st</sup> appeal dated **30-07-2018** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

The First Appellate Authority through Order Case No. 2091/ZC/SLPZ/GHMC/2018 dated 21-08-2018 directed the Public Information

Officer to furnish full/ complete information within 7 days to the appellant and the

appeal is closed.

Stating that the appellant was not satisfied with the reply of the First

Appellate Authority, he preferred this  $2^{nd}$  appeal before this Commission requesting

to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing

on 17-08-2019 at 10.30 AM.

The case was heard on 17-08-2019. The appellant was present. The Public

Information Officer and the First Appellate Authority were absent. Hence, the case

is **adjourned**.

In view of the above, with a request to both the parties to attend for hearing

on 26-04-2021 at 10.30 AM.

The Case was heard on 26-04-2021. The appellant was absent. The PIO/

Sri.P.Madhu, Town Planning Supervisor, GHMC, Circle-21, Chanda Nagar,

Rangareddy District was present and stated before the Commission that vide letter

Lr.No.RTI/59/60/TPS/Cir-21/2018, dated.29-05-2018 they informed the

appellant the information sought by him pertains to HMDA and DTCP.

The Commission perused the material papers available on records that the

PIO has informed the appellant that the information sought by the appellant

pertains to HMDA and DTCP but failed to provide the copy of the postal proof of

dispatch.

Therefore the Commission directs the PIO to furnish the letter once again to

the appellant within one week through registered post with acknowledgement due

and to report compliance to the Commission. The Commission also advises the

appellant to file a separate 6(1) application before the concern PIO's and seek the

required information.

With the above direction, the appeal is closed.
