Order

Sri V. Kanthaiyah has filed second appeal dated **25-10-2018** which was received by this Commission on **25-10-2018** for not getting the information sought by him from the Public Information Officer/ O/o the Deputy Commissioner, GHMC., Circle-21, Chandanagar, Ranga Reddy District and the First Appellate Authority/ O/o the Zonal Commissioner, Serilingampally Zone, Ranga Reddy District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **05-06-2018** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

- 1) ARRANGMENT BETWEEN WHINE AND HERITAGE OF MONTHLY RENT, MEASUREMENTS, PERIODS ETC FOR BRAND ADVERTISE THROUGH CONSTRUCTED 12 PILLARS WITH WRITE ROAD NUMBERS AND PLOT NUMBERS DISPLAY PILLARS AT JUBILEE GARDEN KONDAPUR. ARDRA
- 2) LAYOUT PLAN SUPPLIED TO HERITAGE OF WRITEN ROAD AND PLOT NUMBERS ON SAID PILLARS BY SAID HERITAGE.
- 3) PROCEEDINGS AND SANCTIONED RS 49 LACS WORK OF R.C.C. SLABS OVER OPEN DRAINAGE IN JUBILEE GARDEN KONDAPUR W. 107.
- 4) SCHEDULE OF TIME OF COMPLETION OF SAID WORK ON OPEN DRAINAGE.

The Public Information Officer through Letter dated 04-07-2018 informed to the appellant that for point no. 1 & 3 forwarded to Advertisement department & Engineering section and for Point No. 2 the search has been made in the record section and observed that the said information is not available. Therefore requested to furnish the details to file No. & Permit No.

The Public Information Officer through Letter dated 13-07-2018 furnished available information to the appellant.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1st appeal dated **17-07-2018** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

The First Appellate Authority through Order dated 31-07-2018 directed the Public Information Officer to furnish full/ complete information within ten days to the appellant and the appeal is closed.

Stating that the appellant was not satisfied with the reply of the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing on **21-08-2019 at 10.30 AM.**

The Case was heard on 26-04-2021. The appellant was absent. The PIO/ Sri.P.Madhu, Town Planning Supervisor, GHMC, Circle-21, Chanda Nagar, Rangareddy District was present and stated before the Commission that vide letter Lr.No.RTI/68/TPS/Cir-21/2018, dated.04-07-2018 part information was furnished to the appellant. The PIO further submitted a copy of the information before the Commission.

The Commission directs the PIO to furnish the complete information to the appellant within one week through Registered post with acknowledgement due and to report compliance to the Commission. If the PIO fails to follow the instructions issued, action will be taken against the PIO as per section 20 of the RTI Act.

With the above direction, the appeal is closed.
