Order

Sri. K. Ramakrishna has filed complaint dated **26-10-2018** which was received by this Commission on **29-10-2018** for not getting the information sought by him from the Public Information Officer/ O/o the Chief General Manager, The SCCL., Manuguru, Bhadradi – Kothagudem District.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **24-02-2018** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

- ① 2014-15, 2015-16, 2016-17 సంవత్సరాలవారినా P.V కలనెల్లూరి భద్రాద్రి - స్టేడియంకు కేటాయించిన నిధుల వివరాలు తెలియ జేయగలను.
- ② భద్రాద్రి స్టేడియం నిధులను ఖర్చు చేసిన విధానం టెండర్ లా సింగిల్ లీ సంస్థ చేసిన వివరాలు ఇప్పించగలను.
- ③ భద్రాద్రి స్టేడియం నిధుల ఖర్చు వివరాలకు ఇప్పించగలను. మరియు అన్ని అభివృద్ధిల వివరాలు, రేషన్లు పకలు కవల ఇప్పించగలను.
- ④ C.E.R club కు క్రీడా సామగ్రి కోసం కేటాయించిన నిధుల వివరాలు ఇప్పించగలను. 2015, 2016, 2017 సంవత్సరాలవారినా ఇప్పించండి.
- ⑤ C.E.R club క్రీడా సామగ్రి కోసం రేషన్లు ఇప్పించగలను. మరియు ఉన్నత స్థాయి క్రీడా సామగ్రి వివరాలు. 2015, 2016, 2017 సంవత్సరాల వారినా, వారినా వివరాలు ఇప్పించగలను.

The Public Information Officer through Ref.No. MNG/PER/RTI/342 dated 24-02-2018 informed to the complainant that the postal stamp has not attested along with the application. Hence, the application has returned to the complainant.

Stating that the complainant was not satisfied with the reply of the Public Information Officer, he preferred this complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing on **19-04-2021 at 10.30 AM.**

The Case was heard on 19-04-2021. The complainant was absent. Due to the Covid -19 Pandemic, the PIO vide mail dated.17-04-2021 requested the Commission to hear the case over phone, the Commission accepted the plea made by the PIO and so the case was heard over phone on 19-04-2021. The PIO/Sri.V.Rameshwara Rao, Sr.PO,O/o. General Manager, Munuguru Area has responded and stated that have not received the application filed by the complainant and so they were unable to furnish the information. The PIO further requested the Commission they will provide the information within one week to the complainant.

The Commission perused the material papers available on records and observed that the then PIO vide letter Ref.No.MNG/PER/RTI/342 dated. 24-02-2018 has rejected the 6(1) application dated.24-02-2018 filed by the complainant.

Therefore the Commission accepted the plea made by the PIO and directs the PIO to furnish the information to the complainant within one week from the date of receipt of this order through registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
