<u>Order</u>

Sri B. Rakesh Kumar has filed second appeal dated **25-11-2019** which was received by this Commission on **04-12-2019** for not getting the information sought by him from the Public Information Officer/ O/o the Osmania General Hospital, Hyderabad and the First Appellate Authority/ O/o the Osmania General Hospital, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **14-12-2018** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

- 1. In medico legal case ,Beaten with stone on left wrist. In this scenario ,without blood coming out A () () () and without brucing from left wrist, internal bone of the left wrist will fracture . is it correct?.
- 2. In medico legal case ,Beaten with stone on left wrist of the hand. In this scenario,doctor should write blood visibility/brucing of the left wrist on case sheet without indicating the blood visibility/brucing of the left wrist on case sheet ,can doctor issue the bone fractured in left wrist and injury is grevious in medical report?
- 3. In medico legal case, doctor (private or govt) should enter the victim/patient name, date, time stamp, when victim/patient came to hospital, how the patient/victim condition like blood bleeding/injuries on body, date of crime, time stamp of crime, if the private doctor is not indicated above details(victim/patient name, date, time stamp, when victim/patient came to hospital, how the patient/victim condition like blood bleeding/injuries on body, date of crime, time stamp of crime). Is it correct .please give me the answer in full sentence so that judge will understand.

More (10) points.

Stating that the appellant did not get any response from the Public Information Officer, he filed 1st appeal dated **06-03-2019** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2^{nd} appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing on **20-04-2019 at 10.30 AM**.

The Case was heard on 20-04-2021. The appellant was absent. The PIO/Dr.T.Sai Shobha, DCS.RMO, Osmania Hospital, Hyderabad was present and stated before the Commission that they have not received the application filled by the appellant and requested the Commission to provide them one week to furnish the information.

The Commission accepted the plea made by the PIO and directed the PIO to furnish the information within one week through registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
