## Order

Sri Shaik Khaja Hussain has filed second appeal which was received by this Commission on **09-12-2019** for not getting the information sought by him from the Public Information Officer/ O/o the Dy. Commissioner, GHMC., Circle-20, Serilingampally, Ranga Reddy District and First Appellate Authority/ O/o. the Zonal Commissioner, GHMC., Serilingampally, Ranga Reddy District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **28-03-2019** before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

The following information may be furnished to me, as soon as possible, relating to the **BUILDING PERMISSION** in Property of bearing GHMC H No.1-60-30/222/136, at T Anjaiah Nagar, Gacchi Bowli, K.V. Ranga Reddy District, Telangana State, Pin No.500084,

Kindly provide me; I would like to know the following:

- INTERFOIL

- आर्डर

- 1.) A Certified attested of Copy of **APPLICATION** along with all link documents Enclosures and **SITE PLAN** submitted by Applicant,
  - 2.) A Certified attested of Copy of **1<sup>st</sup> First and Final Challan Fees Details**,
  - 3.) A Certified attested of Copy of **1<sup>st</sup>First NOTICE** and Final **NOTICE** along with **Acknowledgments** signed by Property owner,
  - 4.) A Certified attested of Copy of **SITE VISIT REPORT**,
  - 5.) A Certified attested of Copy of **Building PERMIT ORDER** along with **PLAN**,

The Public Information Officer through Letter dated 03-05-2019 informed to the appellant that as soon as the consent is received from the owner their office will furnish the required information.

Since the appellant was not satisfied with the reply of the Public Information Officer, he filed 1<sup>st</sup> appeal dated **07-05-2019** before the 1<sup>st</sup> Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The First Appellate Authority through Notice dated 10-05-2019 directed the Public Information Officer and the appellant to appear for hearing on 20-05-2019 @ 3.00 PM along with related records/ documents.

The First Appellate Authority through Order dated 22-05-2019 informed that the Assistant Public Information Officer/ Section Officer, Cir-20 stated that, the information has been sought to the appellant vide letter dated 03-05-2019. The First Appellate Authority has acknowledged the same and closed the appeal.

Stating that the appellant was not satisfied with the reply of the First Appellate Authority, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal has been taken on file and Notices issued to both the parties for hearing on **27-04-2021 at 10.30 AM.**

The Case was heard on 27-04-2021. The appellant is present and in his affidavit filed he stated that the PIO has not furnished any kind of information till date. The PIO/ Sri.A.Balraj, Superintendent, GHMC, Circle – 20, Serilingampally Zone is present and stated that a letter Lr.No.RTI/C20/53/28/3/2019/85, dated.03-05-2019 was forwarded to the third party U/s.11(1) of the RTI Act 2005 seeking his consent whether to furnish his information sought to the appellant and there is no reply from the concerned party till date. Hence the information was not furnished to the appellant.

Heard both the parties and perused the material papers available on record. The Commission observed that the appellant is seeking information for 5 points through his 6(1) application dated.28-03-2019 and the same comes under public document. The Commission warns the PIO not to repeat the same in the future and furnish the information by following the provisions of section 8(1)(j) of the RTI Act 2005.

The Commission directs the PIO to furnish the information to the appellant except the copies of documents/link documents enclosed to the application at point No.1 which are treated as documents covered U/s.8(1)(j) of the RTI Act 2005 within one week through RPAD and to report compliance to the Commission.

With the above direction, the appeal is closed.
