## Order

Sri Syed Azeemuddin has filed complaint dated **03-12-2019** which was received by this Commission on **11-12-2019** for not getting the information sought by him from the Public Information Officer/ O/o the Osmania General Hospital, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **13-11-2019** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

I, SYED AZEEMUDDIN s/o Syed Ahmed, r/o H.No.8-3-623, Yellareddyguda, Amirpet, Hyderabad, submits the following:-  
I am the grand son of SYED GHULAM MOHIUDDIN. That my said grand father was died on 1.9.1959. That he was brought to the hospital for medical treatment for Asthema during the medical treatment he was died. That when I approached the GHMC for issuance of the death certificate the GHMC authorities has asked me to get the information of death from the Hospital. in pursuance of the said direction I am forced to approach your goodself to issue me the information regarding his death, hence I request your goodself to kindly issue me the certificate regarding his death so that I may submit the same in the GHMC and get the death certificate of my grand father.  
Hence I request your goodself to kindly issue me the information of death of my grand father SYED GHULAM MOHIUDDIN died on 1.9.1959 under RTI Act of 2005.

The Public Information Officer through Letter dated 23-11-2019 requested the Public Information Officer and Civil Surgeon Administrator, OGH, Hyderabad to furnish the information required by the complainant within (3) days under intimation to their office.

The Public Information Officer through Letter dated 07-12-2019 furnished available information to the Complainant.

Stating that the complainant was not satisfied with the reply of the Public Information Officer, he preferred this complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing on **20-04-2021 at 10.30 AM.**

The Case was heard on 20-04-2021. The complainant was present and submitted that the PIO has not provided any information. The PIO/ Dr.T.Sai Shobha, DCS.RMO, Osmania Hospital, Hyderabad was present and stated before the Commission that the appellant is seeking information relating to 50 year old record and also vide letter Rc.No.MRD/RTI-Act/SSA/2018/52, dated.05-12-2019 they informed the complainant that their office maintains medical records for only 10 years and so they were unable to furnish the information. The PIO further submitted a copy of the letter before the Commission.

Heard both the parties and perused the material papers available on records. The Commission observed that the complainant is seeking 50 years old information. Since the PIO has informed the factual position to the complainant, the complaint is closed.
