## Order

Ms/Sri. P. Bharathi has filed second appeal dated **16-11-2018** which was received by this Commission on **17-11-2018** for not getting the information sought by him from the Public Information Officer/ O/o the Deputy Commissioner, GHMC., Circle-21, Chandanagar, Ranga Reddy District and the First Appellate Authority/ O/o the Zonal Commissioner, Serilingampally Zone, Ranga Reddy District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **13-06-2018** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

Inform the steps taken to process my application dated 08-05-2018 and action taken on the letter dated 01-05-2018 received from Metropolitan Commissioner, HMDA.

Stating that the appellant did not get any response from the Public Information Officer, he/she filed 1<sup>st</sup> appeal dated **25-08-2018** before the First Appellate Authority requesting him to furnish the information sought by him/her u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he/she preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him/her u/s 19(3) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing on **25-09-2019 at 10.30 AM**.

The case was heard on 25-09-2019. The appellant was absent. The Public Information Officer was present. The case was **adjourned**. Issue fresh notice to the Public Information Officer/ O/o the Dy.Commissioner, GHMC., Chandanagar, Circle-21.

In view of the above, with a request to both the parties to attend for hearing on 26-04-2021 at 10.30 AM.

The Case was heard on 26-04-2021. The appellant was absent. The PIO/Sri.P.Madhu, Town Planning Supervisor, GHMC, Circle-21, Chanda Nagar, Rangareddy District was present and stated before the Commission that vide letter Lr.No.RTI/135/TPBO/TP/Cir-12/2018, dated.12-11-2018 the available information was already furnished to the appellant through registered post. The PIO further submitted a copy of the letter before the Commission along with the copy of the postal receipt.

Since the available information is furnished, the appeal is closed.
