Order

Ms. N. Nagalakshmi has filed complaint dated **23-12-2019** which was received by this Commission on **19-12-2019** for not getting the information sought by him from the Public Information Officer/ O/o the Sir Ronald Ross Institute of Tropical & Communicable Diseases, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **03-08-2015** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

The undersigned Miss. Nagalakshmi D/o late N. Jangaiah submit that the file pertaining to the subject a copy of it cited/may be made available to me and also the endorsement file transmitted to you by the Collector's letter containing her remarks, which is required by me for further action by me in the matter.

Stating that the complainant did not get any response from the Public Information Officer, she preferred this complaint before the Commission requesting to arrange to furnish the information sought by her u/s 18(1) of the RTI Act, 2005.

The Public Information Officer through Lr.No. 81/RTI/SRRIT&CD/2020/45 dated 23-01-2020 informed to the Commission that the available information was already furnished through registered post acknowledge vide their office Lr.No. GS/SRRIT&CD/2015/571/183 dated 03-08-2015.

In view of the above, with a request to both the parties to attend for hearing on **07-04-2021 at 10.30 AM.**

The Case was heard on 07-04-2021. The complainant was present and submitted that the PIO has not provided the information sought by her. The APIO/ Sri.M.Mohan Das, Administrative Officer, O/o. Sri Ronald Ross Institute of Tropical & Communicable Diseases, Nallakunta, Hyderabad was present and submitted before the Commission that vide letter Rc.No.G.S./SRR ITCD/2015/571/183 dated. 03-08-2015 the information sought by the complainant has been furnished through registered post. The PIO further submitted that the complainant has refused to take the information.

Heard both the parties and perused the material papers available on records. The Commission observed that the PIO has furnished the available information to the complainant and the complainant has refused to accept the same stating that she is not satisfied with the same.

The Commission directs the PIO to furnish the information once again to the complainant within one week through registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
