## **Order**

Sri Anjum Abida has filed second appeal dated **06-02-2019** which was received by this Commission on **07-02-2019** for not getting the information sought by him from the Public Information Officer/ O/o the Drugs Control Administration, Vengalrao Nagar, Hyderabad and the First Appellate Authority/ O/o the Drugs Control Administration, Vengalrao Nagar, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **24-11-2018** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

1. As per the Citizens Charter within how many days action is to be taken/completed for Tappal/ Application/File/Memo.
2. Please furnish the Action taken on the file Memo No. 10059/C2/2018 dated 08.11.2018 of Government of Telangana, HM & FW (C) Dept. which was sent through personal messenger to Director Peshi on 08.11.2018.
3. Please furnish copy of the Note file of the file Memo No 10059/C2/2018 dated 08.11.2018.

Stating that the appellant did not get any response from the Public Information Officer, he filed 1<sup>st</sup> appeal dated **29-12-2018** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

The First Appellate Authority through Lr.Rc.No.170/RTI/2018 dated 21-01-2019 furnished available information to the appellant.

Stating that the appellant was not satisfied with the reply of the First Appellate Authority, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

The Public Information Officer through Lr.Rc.No.170/RTI/2018 informed to the Commission that the requested information have already been furnished to the applicant on 21-01-2019.

In view of the above, with a request to both the parties to attend for hearing on **06-04-2021 at 10.30 AM.**

The Case was heard on 06-04-2021. The appellant was present. The APIO/ O/o. Sri.K,Venugopal, Senior Assistant, O/o. Drugs Control Administration, Vengalrao Nagar, Hyderabad was present and submitted that the vide letter Rc.No.170/RTI/2018, dated. -01-2019 the Appellate Authority has furnished the information to the appellant through registered post. The PIO further submitted a copy of the information along with the copy of the postal receipt.

The Commission perused the material papers available on records and observed that the PIO has furnished the information to the appellant.

Since the information is furnished, the appeal is closed.
