Order

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **19-11-2019** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

Stating that the complainant did not get any response from the Public Information Officer, he preferred this complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the Covid-19 pandemic, with a request to both the parties to attend for telephonic hearing on 16-06-2021 at 11.00 AM.

In view of the Covid -19 Pandemic, the case is heard over phone on 16-06-2021 with prior intimation to the concerned parties. The complainant did not respond. The PIO /Sri.Rajeshwar Reddy, Superintendent, O/o. The District Revenue Officer, Medchal Malkajgiri District responded and submitted a letter Lr.No.A3/RTI/322/2021, dated.14-06-2021 from the DRO, Medchal Malkajgiri District stating that the information sought by the complainant comes under confidential under section 8(j) and 11(1) of the RTI Act.

The Commission directs the PIO to call the complainant for verification of records as per section 2(j) of the Act by issuing prior intimation to the complainant and furnish the information following the guidelines of section 8(1)(j) of the Act and to report compliance to the Commission.

With the above direction, the complaint is closed.
