

Order

Sri V. Anil Kumar has filed complaint dated **28-12-2019** which was received by this Commission on **31-12-2019** for not getting the information sought by him from the Public Information Officer/ District Revenue Officer, Medchal – Malkajgiri District.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **09-04-2019** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:



The Public Information Officer through Lr.No. A3/RTI/178/2019 dated 22-04-2019 requested the Section Superintendent-E, Collectorate, Medchal – Malkajgiri District to furnish available information to the appellant through RPAD under intimation to their office.

The Public Information Officer through Memo No. E1/1148/2019/RTI dated 28-05-2019 requested the complainant to refer the G.O. for all the query raised in the petition and also it is informed that the delay caused in providing information was due to the Heavy Election Work.

Stating that the complainant did not get any response from the Public Information Officer, he preferred this complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the Covid-19 pandemic, with a request to both the parties to attend for telephonic hearing on **16-06-2021 at 11.00 AM**.

In view of the Covid -19 Pandemic, the case is heard over phone on 16-06-2021 with prior intimation to the concerned parties. The complainant responded and stated that the PIO has not provided the information sought by him. The PIO /Sri.Lingaya Naik, District Revenue Officer, Medchal Malkajgiri District responded and stated that vide letter No.E1/1148/2019/RTI, dated. 28-05-2019 the information sought by the complainant was furnished.

Heard both the parties and perused the material papers available on record. The Commission observed that the PIO has not furnished the complete information sought by the complainant.

The Commission directs the PIO to furnish the complete information sought by the complainant through his 6(1) application dated.09-04-2019 within one week through RPAD and to report compliance to the Commission. If the PIO fails to comply with the instructions issued, action will be taken against the PIO as per section 20 of the RTI Act, 2005.

With the above direction, the complaint is closed.
