## Order

Sri B. Bharath Bhusan has filed second appeal dated **06-12-2018** which was received by this Commission on **10-12-2018** for not getting the information sought by him from the Public Information Officer/ O/o the Director (PA&W), SCCL., Kothagudem, Bhadradri – Kothagudem District and the First Appellate Authority/ O/o the Director (PA&W), SCCL., Kothagudem, Bhadradri – Kothagudem District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **27-08-2018** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

- 2) Office Order No CRP/PER/C/15/1828, Dt. 19-07-2014 (ప్రకారం మరియు Terms & Conditions of Appointment లోని U/Clause-7 (ప్రకారం JET (Civil) E-2 Grade గా Training పూర్తి అయిన తరువాత EE (Civil) E-3 Grade గా నాకు ప్రమోషన్ ఇవ్వాలి కాని నేను Training పూర్తి చేసి 4 సంగరాలు దాటిపోతున్నా! నాకు ఇంతవరకు EE (Civil) E-3 Grade గా ప్రమోషన్ ఇవ్వలేదు. అందుకు సంబందించిన కారణాలను తెలుపగలరు మరియు నాకు ప్రమోషన్ ఇస్తారా? లేదా? కూడా వివరంగా తెలియజేయగలరు.

The Public Information Officer through Ref.No. CRP/RTI-PIO/2657/1139 dated 08-08-2018 requested GM(P)/EE Cell to furnish the sought information to the appellant.

The Public Information Officer through Ref.No. CRP/RTI-PIO/2657/1139 dated 08-09-2018 requested the GM(P)/EE Cell to furnish the sought information to the appellant.

Stating that the appellant was not satisfied with the reply of the Public

Information Officer, he filed 1st appeal dated **08-10-2018** before the First Appellate

Authority requesting him to furnish the information sought by him u/s 19(1) of the

RTI Act, 2005.

The First Appellate Authority through Ref.No.CRP/HRD/RTI-

AA/540/2657/2914 dated 23-10-2018 requested the GM (Pers) & PIO, Corporate

& Hyd Areas to furnish the sought information to the appellant.

The Public Information Officer through Ref.No.CRP/RTI-PIO/2657/1327

dated 27-10-2018 requested the GM(P)/EE Cell to furnish the information

immediately, so as to enable to forward the same to the applicant.

Stating that the appellant was not satisfied with the reply of the Public

Information Officer and the First Appellate Authority, he preferred this 2<sup>nd</sup> appeal

before this Commission requesting to arrange to furnish the information sought by

him u/s 19(3) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing

on **19-04-2021 at 10.30 AM**.

The Case was heard on 19-04-2021. The appellant was absent and through

his mail dated.01-04-2021 submitted a withdrawal letter stating that the

information sought by him has been furnished by the PIO on 27-08-2018. The

PIO/Sri.D.Srinivas, Deputy General Manager(Personnel), O/o.SCCL, Kothagudem,

Bhadradri Kothagudem District was present and stated before the Commission

that the information sought by the appellant was furnished in their office and the

appellant has also submitted a withdrawal letter. The PIO further submitted a

copy of the letter before the Commission.

Since the information is furnished, the appeal is closed.
