## **Order**

Sri Syed Ismail has filed second appeal dated **02-07-2017** which was received by this Commission on **03-07-2017** for not getting the information sought by him from the Public Information Officer/ The Deputy Tahsildar, Uppal Mandal, Medchal – Malkajgiri District and the First Appellate Authority/ The Revenue Divisional Officer, Keesara Division, Medchal – Malkajgiri District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **30-11-2016 (6(1) application not enclosed)** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the Public Information Officer, he filed 1<sup>st</sup> appeal dated **31-01-2017** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the Covid-19 pandemic, with a request to both the parties to attend for telephonic hearing on **04-06-2021 at 11.00 AM.**

In view of the Covid -19 Pandemic, the case is heard over phone on 04-06-2021 with prior intimation to the concerned parties. The appellant responded and stated that the PIO has not furnished the information. The PIO /Sri. Rafiuddin, Deputy Tahsildar, Uppal Mandal, Medchal Malkajgiri District responded and submitted a letter Lr.No.RTI/101/2018, dated.01-05-2021 stating that the file bearing No.B/9459/11 has been submitted to the Collector. The PIO further stated that the same file was also furnished to the appellant through speed post and submitted a copy of the endorsement along with the postal receipt.

The Commission directs the PIO to furnish certified copy of the information to the appellant within one week through registered post with acknowledgement due and report compliance to the commission.

With the above direction, the appeal is closed.
