Order

Sri M. Muthyalu Goud has filed complaint dated **20-02-2019** which was received by this Commission on **20-02-2019** for not getting the information sought by him from the Public Information Officer/ Deputy Tahsildar, Ghatkesar Mandal, Medchal – Malkajgiri District.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **02-11-2018** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

- 2) ప్లాటనం పేరు "పెరిఫెక్షన్" చేసిన B.L.O మెరియ ఫిల్డ్ సిబ్బంది సమాచారం ఇవ్వగలరు
- 1) బతుపరచిన బొబిలాలా పేర్లు సంబంధించిన ఫామ్. 6, Id, Residence, Age, ఇతర వివరాల దృవీకరణ పత్రములు బతుపరచి డుట్రో వారి కిచ్చాలను దృవీకరించి ఇవ్వగలరని మనవి

Stating that the complainant did not get any response from the Public Information Officer, he preferred this complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the Covid-19 pandemic, with a request to both the parties to attend for telephonic hearing on **08-06-2021 at 11.00 AM.**

The complainant responded and stated that the PIO has not furnished the information. The PIO /Sri.Ashwin, Deputy Tahsildar, Ghatkesar Mandal, Medchal Malkajgiri District responded and submitted an endorsement letter Lr.No.C/RTI/15-83/2021, dated.07-05-2021 stating that the information sought by the complainant is regarding issuance of Voter Id's and their enclosures. The PIO further submitted that the information sought is not specific and also vast information.

The Commission directs the PIO to call the complainant for verification of records as per section 2(j) of the Act by issuing prior intimation to the complainant and furnish the information following the guidelines of section 8(1)(j) of the Act and to report compliance to the Commission.

With the above direction, the complaint is closed.
