Order

Sri Mohd. Ahmed has filed complaint dated **07-03-2019** which was received by this Commission on **08-03-2019** for not getting the information sought by him from the Public Information Officer/ The Principal, DCMS College of Physiotherapy, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **26-11-2018** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

Respected Sir,
Sub:- Application to furnish details of my wife namely Mrs. Rayees Unissa, Asst. Professor (Lecturer) in B.P.T. DCMS college of physiotherapy, Affiliated to Dr.NTR University of health sciences, A.P, Vijayawada – Reg.

I the undersigned wish to state the following few lines for your kind consideration and necessary action.

I submit that there is a family dispute between me and my wife Mrs. Rayeesunissa and she filed 3 cases against me including a case for maintenance, DVC, both cases asking maintenance, I already got a working latter 15-4-2018, i submitted in civil court, High Court. needed a one more original latter.

I submit that I request to furnish the details of Mrs. Rayeesunissa Viz., the post held by her salary and also since how long she is in service.

I request you to provide the information at the earliest.

I am here with attached the necessary Rs. 10/- court fee stamp as prescribed under the RTA Act.

Stating that the complainant did not get any response from the Public Information Officer, he preferred this complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing on **07-04-2021 at 10.30 AM.**

The Case was heard on 07-04-2021. The complainant was absent but vide letter dated.25-03-2021 submitted a letter before the Commission stating that the information sought by him is furnished and has agreed to withdrawn the case. The PIO/the Principal, DCMS College of Physiotherapy, Kanchanbagh, Hyderabad was absent.

The Commission took a serious view against the PIO for not attending the hearing even after the receipt of notice from the Commission. The Commission directs the PIO to submit explanation for not attending for hearing on this day before the Commission.

Basing on the material papers available on records and the withdrawal letter dated.25-03-2021 submitted by the complainant, the complaint is closed.
