## **Amended Order**

Sri A. Vijaya Bhaskar Reddy has filed 2<sup>nd</sup> appeal dated 20-02-2018 which was received by this Commission on 20-02-2018 for not getting the information sought by him from the PIO / O/o The Tahsildar, Balanagar Mandal, Medchal District and 1<sup>st</sup> Appellate Authority / O/o The Revenue Divisional Officer, Malkajgiri Division, Medchal District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 15-09-2017 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

Application under section 6 (1 ) of RTI Act 2005, for grant of certified copy of alleged order Memo dated 15-4-2012. That is in respect of Sy. No 182/9 to an extent of 16.31 Guntas of Allamthota Bavi Begumpet village Balanagar Mandal in pattedar and possession columns in favour of Sri Irtiaj Ahmed Khan s/o Meraj Khan. 2) Smt Zareena Begun D/o Meraj Ahmed Khan. 3) Smt Raziya Begun W/o Meraj Ahmed Khan. Which is being claimed as found in the file a Xerox copy supplied is enclosed with through their agent of Sri Irtiaj Ahmed Khan Smt Zareena Begun and Smt Raziya Begum kindly verify the existence such a document in the concerned file and if found grant the copy there of to the under signed who are the owners of land covered by Sy.No 187 and 190 of Allamthota Bavi Begumpet village Balanagar Mandal Ranga Reddy District now Medical District.

Xerox copy of alleged memo of Which C.C copy is sought is enclosed for verification of its truth.

Therefore, the applicants pray your good selves may be pleased to enquire into the matter verify the above memo Dated 15/04/2012 where of deputy collector and Tahsildar Balanagar Mandal (RR) Dist now Medchal-Malkajigiri district is existing or not and if available copy of the same may be granted.

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1<sup>st</sup> appeal dated 23-10-2017 before the 1<sup>st</sup> Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority has not responded to the Appellant.

As the appellant did not get the information from the Public Information Officer and non response from the 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

In view of the above, the  $2^{nd}$  appeal has been taken on file and Notices issued to both the parties for hearing on **16-11-2020 at 10.30 AM.** 

The Case was heard on 16-11-2020. The appellant was present and through affidavit submitted that the PIO has furnished only a memo but not the information sought by him in his 6(1) application. The PIO/ Naib Tahsildar, Balanagar Mandal, medchal – Malkajgiri District was absent.

The Commission perused the material papers available on records and found that the PIO has not furnished the information to the appellant. The Commission directs to issue **Show Cause Notice** to the PIO for not responding properly to the RTI Application filed under 6(1) of the RTI Act and also for not attending the hearing even after receiving the notice from this Commission.

The Commission also directs the PIO to furnish the information to the appellant within two weeks through registered post with acknowledgement due. The action on Show Cause Notice will be dealt separately.

With the above direction, the appeal is closed.
