## **Order**

Sri. K. Lingaiah has filed complaint dated **16-03-2019** which was received by this Commission on **18-03-2019** for not getting the information sought by him from the Public Information Officer/ The Main Hospital, O/o the SCCL., Kothagudem, Bhadradi – Kothagudem District.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **08-01-2019** before the Public Information Officer/O/o the SCCL., Kothagudem requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

Respected Sir,  
I, Kambala Lingaiah, bearing M/s SCCL Employee Code: 2836554, was working at SRP-1 Incline, got medical invalidation 07.09.2018.  
My humble request to you is kindly dispense a copy of my "DETAILED MEDICAL INVALIDATION REPORT" for my personal usage only.

The Public Information Officer through Ref.No. CRP/RTI-PIO/2783/71 dated 19-01-2019 requested the CMO Main Hospital to furnish the information on priority as the information is sought under RTI Act, 2005 which is time bound, for onward submission to the applicant.

Stating that the complainant was not satisfied with the reply of the Public Information Officer, he preferred this complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing on **19-04-2021 at 10.30 AM.**

The Case was heard on 19-04-2021. The complainant was absent. The PIO/Sri.D.Srinivas, Deputy General Manager(Personnel), O/o.SCCL, Kothagudem, Bhadradi Kothagudem District was present and stated that vide letter Ref.No.CRP/RTI-PIO/2783/677, dated.28-08-2019 the information sought by the complainant has been furnished through registered post. The PIO further submitted a copy of the information before the Commission along with the copy of the postal receipt.

The Commission perused the material papers available on records and observed that the PIO has furnished the information to the complainant but with an abnormal delay.

The Commission took a serious view against the PIO for not furnishing the information to the complainant within the stipulated period of 30 days as per section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

Since the information is furnished, the complaint is closed.
