Order

Sri Avinash has filed second appeal dated **16-03-2019** which was received by this Commission on **22-03-2019** for not getting the information sought by him from the Public Information Officer/ The Superintendent, O/o the Gandhi Hospital, Hyderabad and the First Appellate Authority/ O/o the Principal Secretary to Govt., HM&FW., Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **05-01-2019** before the Public Information Officer/ O/o the Principal Secretary to Govt., HM&FW, Hyderabad requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

- 1) Please provide complete **CERTIFIED / ATTESTED** copies of Action Taken Report & Enquiry Report in respect of Newspaper item appeared titled as " 'GANDHI' PORUGU SEVALA UDYOGI CHETHIVATAM" and " 'GANDHI' LO SCANNING MAFIA". Copies of above Newspaper clippings enclosed for reference.
- 2) Please provide complete **CERTIFIED / ATTESTED** copies of Suspension Orders, Enquiry Reports, FIR copies, Present stage of Disciplinary case filed against the employees and Latest communication received from Police Department in respect of Newspaper item appeared titled as "HARRASSMENT SLUR ON GANDHI STAFF, FOUR HELD" and " GANDHI LAB STAFF GAG ORDER TO VICTIMS: SHUT UP OR FAIL EXAM" and "GANDHI LO MUGGURU LAB TECHNICIANLU SUSPENSION". Copies of above Newspaper clippings enclosed for reference.
- 3) Please provide complete **CERTIFIED / ATTESTED** copies Suspension Orders, Enquiry Reports & Present stage of Disciplinary case filed against the employee in respect of Newspaper item appeared titled as "NURSE SUSPENDED FOR USING PHONE". A copy of above Newspaper clipping enclosed for reference.
- 4) Please provide complete **CERTIFIED / ATTESTED** copies Action Taken Report & Enquiry Report in respect of Newspaper item appeared titled as "GH SECURITY GUARD CAUGHT WITH A WOMAN". Copy of above Newspaper clipping enclosed.
- 5) Please provide complete **CERTIFIED / ATTESTED** copies Action Taken Report & Enquiry Report in respect of Newspaper item appeared titled as "SALE OF BLOOD SUSPECTED IN GANDHI HOSPITAL". Copy of above Newspaper clipping enclosed.

More (2) points.

The Public Information Officer through Lr.No. 172/VC.2/2019-2 dated 09-01-2019 transferred the application under section 6(3) of RTI Act, 2005 to the Public Information Officer/ O/o the Gandhi Hospital, Hyderabad to furnish the information directly to the applicant.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1st appeal dated **11-02-2019** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing on **20-04-2019 at 10.30 AM.**

The Case was heard on 20-04-2021. The appellant was absent and forwarded a mail dated.24-03-2021 requesting the Commission to permit him to withdraw the appeal. The PIO/ O/o. the Superintendent, Gandhi Hospital, Musheerabad, Secunderabad was also not present. The FAA/Sri.M.Surender Reddy, Assistant Secretary to Government, Health Medical & Family Welfare Department, TS Secretariat, Hyderabad was present and submitted that they have forwarded the application u/s.6(3) of the RTI Act to PIO/O/o. the Gandhi Hospital, Musheerabad, Secunderabad to furnish the information to the appellant.

The Commission perused the material papers available on records and observed that the complainant through his mail dated.25-03-2021 has requested the Commission to permit him to withdraw the appeal. Hence, the complaint is closed.
