Order

Sri G.M. Reddy has filed second appeal dated **23-03-2019** which was received by this Commission on **26-03-2019** for not getting the information sought by him from the Public Information Officer/ O/o the Sarojini Devi Eye Hospital, Hyderabad and the First Appellate Authority/ O/o the Sarojini Devi Eye Hospital, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **20-11-2018** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

My admission no 7750 of 5.8.2019 discharged on 9-8-2017 without checkup whether the operation/surgery of single Right eye cataract fruitful or not after taking history of a person as if it is major surgery or operation causing with death. Please name the doctors engaged in my above said operation which my Right eye was damaged the Right existing than earlier and also later find doctors engaged in the laser operation said not possible by one doctor as said possible by more doctor on 6-7-18 the same doctors. When I remember also checkup from 8-11-2018 to 13-11-2018 have not recorded their finding on the book meant part, to whom you refer by mail 3 to 14 vide SP NO 019991 which amounts escapism by medical negligence, frauds, profession misconduct against the ethics and moral of the medical profession. Hence this application under the Act, furnish their reply. Thanking you. 21-11-2018 & 23-11-2018 are closed to days I was in the station



The Public Information Officer through Lr.Rc.No. 3831/RTISDEH/2018 dated 03-12-2018 furnished available information to the appellant.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1st appeal dated **22-12-2018** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing on **20-04-2019 at 10.30 AM.**

The Case was heard on 20-04-2021. The appellant was absent. The PIO/Dr.Najafi Begum, Civil Surgeon - RMO, O/o. the Sarojini Devi Eye hospital, Mehdipatnam, Hyderabad was present and the FAA/Dr.V.Rajalingam, Superintendent, Sarojini Devi Eye Hospital, Hyderabad was also present. The PIO stated before the commission that vide letter Rc.No.3831/RTI/SDEH/2018, dated.03-12-2018 the information sought by the appellant has been furnished through registered post. The PIO further submitted a copy of the information before the Commission along with the copy of the postal receipt.

The Commission perused the material papers available on records and observed that the PIO has furnished the information to the complainant.

Since the information is furnished, the appeal is closed.
