Order

Sri Shrinivas has filed second appeal dated **26-03-2019** which was received by this Commission on **26-03-2019** for not getting the information sought by him from the Public Information Officer/ O/o the DM&HO., Medchal – Malkajgiri District and the First Appellate Authority/ District Revenue Officer, Medchal – Malkajgiri District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **28-09-2018** before the Public Information Officer/ O/o the District Collector, Medchal – Malkajgiri District requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

7. Particulars of information required

This is regarding **“THIRUMALA MATERNITY, SURGICAL AND GENERAL HOSPITAL”** which never followed any rules and regulations meant for maternity hospital & built G+2 within 100 sq yards from **19 years (RTI/445/AHMO-2/GHMC/2016 dt 23-08-2016)**. Actually hospital runs by **DR Anuradha BAMS & Dr Ramachadraih BSc MBS (osm)**. While **DR Anuradha BAMS** is doing **“OBSTETRICIAN-GYNECOLOGIST”** duties and treats for any patients it is whoever may be without proper specializations. And **DR Anuradha BAMS** prescribed **“ALLOPATHIC MEDICINES”** which are used sold in **“LAXMI MEDICAL”** stores. But **“Drugs Control Administration”** caught **DR Anuradha BAMS** and **“LAXMI MEDICAL”** stores. And in the report dated on **17-03-2017** it is clearly mentioned that **DR Anuradha BAMS** degree prescribed **“ALLOPATHIC MEDICINES”**. This is how **“Thirumala Hospital”** run by **DR Anuradha BAMS & Dr Ramachadraih BSc MBS (osm)** does not care **“PUBLIC HEALTH AND SAFETY WHILE PRESCRIBING ALLOPATHIC MEDICINES” AT ALL**. Hospital authority saying they had permission to run from **19 years RTI letter**.

Till now **HM&FWD/ DM&HO** dint not gave any information, but on **16-05-2018**, **DR DASYA NAYAK** told he cancelled, Reg No 1588, **Re.No.60/E5/DM&HO/MDCL/RTI/2017-316**. Even the matter is in **HONORABLE “HIGH COURT”**, at our premise and told that **“THIRUMALA HOSPITAL”** is shifted to **NEW PREMISES**.

I requested **HM&FWD/ DM&HO** to give me following documents through RTI but no reply

- ✓ What action taken against **“THIRUMALA HOSPITAL”** running **BAMS & BSc MBS**?
- ✓ Copy of registered document **“BEFORE”** **DR.ANUSH:414/DM&HO/RR/2** for **“THIRUMALA HOSPITAL”** running by **BAMS & BSc** .19 years from establishment.
- ✓ What take action against **DR.ANUSH** who is allowing unqualified person **DR Anuradha BAMS** in treating the patients **“OBSTETRICIAN-GYNECOLOGIST, I require a copy?”**
- ✓ Is the **MEDICARE 5 BEDS** service certificate valid? Please give me certification as (1588) document, from 19 years i.e. from establishment of **“THIRUMALA HOSPITAL”** Running **BAMS & BSc MBS (osm)”** . **RTI/445/AHMO-2/GHMC/2016 dt 23-08-2016**.

Cancellation of **“THIRUMALA HOSPITAL”** in **(3-13-14/C, RAMANTHAPUR)** done. How same **“THIRUMALA HOSPITAL”** is running in **NEW PREMISES, (3-11-48, RAMANTHAPUR)?**

- ❖ **“ON WHO’S NAME “THIRUMALA HOSPITAL” REGISTERED in NEW PREMISES (3-11-48, RAMANTHAPUR)? I require a copy?”**

..... **“ON WHO’S NAME “THIRUMALA HOSPITAL”**

The Public Information Officer through Lr.No. A3/RTI/484/2018 dated 06-10-2018 transferred the application under section 6(3) of RTI Act, 2005 to the Public Information Officer/ DM&HO., Medchal – Malkajgiri District to furnish the sought information directly to the applicant through registered post with acknowledgment and under intimation to their office.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1st appeal dated **Nil** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing on **06-04-2021 at 10.30 AM.**

The Case was heard on 06-04-2021. The appellant was absent. The PIO/O/o. the District Medical & Health Officer, Medchal, Medchal Malkajgiri District was also absent.

The Commission perused the material papers available on records and observed that the PIO has not furnished the information to the appellant as sought by him through his 6(1) application. The Commission took a serious view against the PIO for furnishing the information to the appellant and for not attending for hearing even after receipt of notice from the Commission and directed to issue **Show Cause Notice** to the PIO/O/o. the District Medical & Health Officer, Medchal, Medchal Malkajgiri District.

The Commission also directs the PIO to furnish the information to the appellant within one week from the date of receipt of this order through registered post with acknowledgement due and to report compliance to the Commission. The order on **Show Cause Notice** will be dealt separately.

With the above direction, the appeal is closed.
