Order

Sri GK. Sampath Kumar has filed second appeal dated **03-03-2018** which was received by this Commission on **03-03-2018** for not getting the information sought by him from the Public Information Officer/ O/o the AGM (Vigilance), O/o the SCCL., Kothagudem, Bhadradi – Kothagudem District and the First Appellate Authority/ O/o the GM (HRD), SCCL., Kothagudem, Bhadradi – Kothagudem District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **15-12-2017** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

Information under RTI Act 2005
① - Please furnish the letter number and date of appointing officer for conducting forensic enquiry report on my Bank Accounts No. 6360 and 20484 for huge amounts for the year 2004 to 2011.
② - Please furnish the letter number and the date of letter addressed/sent to my concerned officer to my concerned head of the department to :- my Area General Manager of Kothagudem where I was worked upto 21-01-2015 after completion of my forensic enquiry from 23-2-2012 to 28-2-2012. I addressed letter No. CRP/VIG/2015/6/53, dt. 01.12.2015 to my presenting officer Sri N. Chakravarthy, Dem (PFA) Accounts department enclosing 7 employees statements. Please confirm the said 7 employees who have given written statement against me were enquired by the Enquiry officer who have (Prona Sure) enquired me on 27.2.2012 and as per the period of enquiry from 23.02.2012 to 28.02.2012. Please furnish the date of the said employees were enquired by the forensic enquiry officer who got appointed on 28.02.2012.
③ - Please furnish the number of employees transferred on their individual request from Jan 2017 to Nov 2017
yours faithfully

Stating that the appellant did not get any response from the Public Information Officer, he filed 1st appeal dated **03-01-2018** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing on **05-02-2019 at 10.30 AM.**

The case was heard on 05-02-2019. The appellant and the Public Information Officer both are present. The Public Information Officer submitted that the subject matter relates to AGM (Vigilance) and he is not aware of the facts of the same. The case is **adjourned**. Call the deemed Public Information Officer, AGM (Vigilance), SCCL., Kothagudem Post on the next date of hearing.

In view of the above, with a request to both the parties to attend for hearing on **19-04-2021 at 10.30 AM.**

The Case was heard on 19-04-2021. The appellant was absent. The PIO/Sri.D.Srinivas, Deputy General Manager(Personnel), O/o.SCCL, Kothagudem, Bhadradri Kothagudem District was present and stated that vide letter Ref.No.CRP/RTI-PIO/2443/256, dated.06-03-2018 the available information has been furnished to the appellant through registered post. The PIO further submitted a copy of the information along with the copy of the postal acknowledgement.

Heard the PIO and perused the material papers available on records. The Commission observed that PIO has furnished the available information to the appellant.

Since the information is furnished, the appeal is closed.
