<u>Order</u>

 - 10) Please furnish detailed complete <u>CERTIFIED / ATTESTED</u> copies of Action Taken Report in respect of Misappropriation of <u>Rs. 6.50.000/-</u> caused by concerned Public Authorities of Gandhi Medical College, Secunderabad, as appeared in Sakshi Telugu Newspaper on <u>Dated: 22/02/2019</u> titled as <u>"GANDHI NURSING COLLEGE PRINCIPAL PI CHARYA THISUKOVALI"</u>. A copy of Newspaper clipping is enclosed for kind perusal.

Stating that the complainant did not get any response from the Public Information Officer, he preferred this complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing on **07-04-2021 at 10.30 AM.**

The Case was heard on 07-04-2021. The complainant was absent. The APIO/ Sri.T.J.David, Office Superintendent, O/o. the Director of Medical Education, Koti, Hyderabad was present and stated that vide letter Rc.No.8853/RTI/VC3/2019, dated.29-03-2019 and also vide letter Rc.No.8853/RTI/VC3/2019, dated.29-03-2019 the 6(1) application filed by the Complainant has been forwarded u/s.6(3) of the RTI Act 2005 to the PIO/the Government Maternity Hospital, Sultanbazar, Hyderabad and the PIO/Gandhi Hospital, Secunderabad to furnish the information to the complainant. The PIO further submitted a copy of the letter before the Commission.

The Commission directs the PIO/ the Government Maternity Hospital, Sultanbazar, Hyderabad and the PIO/Gandhi Hospital, Secunderabad to furnish the information to the complainant within one week from the date of receipt of this order through registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
