Sri V. Shyam has filed second appeal dated **08-04-2019** which was received by this Commission on **08-04-2019** for not getting the information sought by him from the Public Information Officer/ O/o the Dy. Commissioner, GHMC., Circle-20, Serilingampally, Ranga Reddy District and First Appellate Authority/ O/o. the Zonal Commissioner, Greater Hyderabad Municipal Corporation, Serilingampally Zone, Ranga Reddy.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **29-10-2018** before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

And 4 other points.

Since the appellant did not receive the information from the Public

Information Officer, he filed 1st appeal dated 22-01-2019 before the 1st Appellate

Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information

sought by him.

The First Appellate Authority through Notice dated 29-01-2019 directed the

Public Information Officer and the appellant to appear for hearing on 18-02-2019

@ 3.00 PM along with related records/ documents.

Stating that the appellant was not satisfied with the reply of the First

Appellate Authority, he preferred this 2nd appeal before this Commission requesting

to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal has been taken on file and Notices issued

to both the parties for hearing on 27-04-2021 at 10.30 AM.

The Case was heard on 27-04-2021. The appellant was absent. The PIO/

Sri.A.Balraj, Superintendent, GHMC, Circle-20, Serilingampally Zone was present

and stated before the Commission that the information sought by the appellant is

vast and voluminous and also not specific.

Heard the PIO and perused the material papers available on record. The

Commission observed that the appellant through his 6(1) application dated.

29-10-2018 is seeking huge and voluminous information. The Commission took a

serious view against the PIO for not following the provision of section 7(1) of the

RTI Act and warns the PIO not to repeat the same in future. The Commission

advises the appellant to seek specific information by filing a separate 6(1)

application before the concerned PIO.

In view of the above, the appeal is closed.
