Order

Sri K. Suresh Kumar filed complaint dated **03-04-2019** which was received by this Commission on **12-04-2019** stating that the Public Information Officer/ O/o the GM, HR Dept (Recruitment Cell), The SCCL., Bhadradi – Kothagudem District did not implement the Commission Order in Appeal No. 11347/CIC/2018 dated 05-02-2019.

The complainant stated that he was not satisfied with the reply of the Public Information Officer, he preferred these Complaints before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing on **19-04-2021 at 10.30 AM.**

The Case was heard on 19-04-2021. The complainant was present and through affidavit submitted before the Commission that the PIO has furnished the information but with a delay even after the directions of the Commission. The PIO/Sri.D.Srinivas, Deputy General Manager(Personnel), O/o.SCCL, Kothagudem, Bhadradi Kothagudem District was present and stated that the Commission in the Complaint No.11347/CIC-(peshi-2)/2018 in appeal No.8046/CIC/CIC(Peshi-2)/2017 order dated.05-02-2019 has directed the PIO to furnish the answer key to the complainant within one week for which the PIO submitted that vide letter Ref.No.CRP/PER/R/2019/446, dated.03-06-2019 the answer key sought by the complainant has been furnished through registered post. The PIO further submitted a copy of the information before the Commission.

The Commission perused the material papers available on records and observed that the PIO has furnished the information to the complainant but with an abnormal delay.

The Commission took a serious view against the PIO for not furnishing the information to the complainant within the stipulated period of 30 days as per section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

Since the information is furnished, the complaint is closed.
