Order

Sri ISN Vinoda Reddy filed a complaint which was received by this Commission on **22-04-2019** stating that the Public Information Officer/ District Revenue Officer, Medchal – Malkajgiri District did not implement the Commission Order in Appeal No. 6403/CIC/2018 dated 07-03-2019.

The complainant stated that he was not satisfied with the reply of the Public Information Officer, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the Covid-19 pandemic, with a request to both the parties to attend for telephonic hearing on **16-06-2021 at 11.00 AM.**

In view of the Covid -19 Pandemic, the case is heard over phone on 16-06-2021 with prior intimation to the concerned parties. The complainant responded and stated that the PIO has not provided the information sought by him. The PIO /Sri.Lingaya Naik, District Revenue Officer, Medchal Malkajgiri District responded and submitted a letter Lr.No.E1/2764/2019/RTI, dated.30-04-2021 stating that the 6(1) application filled by the complainant is forwarded u/s.6(3) of the RTI Act 2005 to the PIO/O/o.the Assistant Commissioner of Police, Pet Basheerbad to furnish the information to the complainant and submitted a copy of the letter before the Commission.

Heard both the parties and perused the material papers available on record. The Commission observed that the PIO has not furnished the complete information by the complainant.

The Commission directs the PIO/O/o.the Assistant Commissioner of Police, Pet Basheerbad to furnish to the information to the complainant within one week through RPAD and to report compliance to the Commission. If the PIO fails to comply with the instructions issued, action will be taken against the PIO as per section 20 of the RTI Act, 2005.

With the above direction, the complaint is closed.
