Order

Sri J. Mahesh has filed complaint which was received by this Commission on **23-04-2019** for not getting the information sought by him from the Public Information Officer/ O/o the Institute of Mental Health, Erragadda, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **27-03-2019** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

The Public Information Officer through Lr.No. RTI Act/IMH/HYD/1153/2019 dated 02-04-2019 informed to the complainant that the application is rejected under RTI section 8(1)(j).

Stating that the complainant was not satisfied with the reply of the Public Information Officer, he preferred this complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

The Public Information Officer through Lr.Rc.No. 2174/RTI/IMH/HYD/2019 dated 02-07-2019 informed to the Commission that they have already given reply to the complainant through Letter dated 07-05-2019.

In view of the above, with a request to both the parties to attend for hearing on **07-04-2021 at 10.30 AM.**

The Case was heard on 07-04-2021. The complainant was absent. The PIO/Dr.D.Manohar, CS-RMO, O/o. the Institute of Mental Health, Erragadda, Hyderabad was present and stated before the Commission that he has taken charge as PIO recently i.e., from 24-03-2021 and so there was delay in furnishing the information. The PIO further stated that the information sought by the complainant is ready and requested the Commission that they will provide the same to the complainant within one week through registered post.

The Commission directs the PIO to furnish the information to the complainant within one week through registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
