## **Order**

Sri J. Sri Ranga Rao filed a complaint dated **02-05-2019** which was received by this Commission on **02-05-2019** stating that the Public Information Officer/ Deputy Tahsildar, Medchal Mandal, Medchal – Malkajgiri District did not implement the Commission Order in Appeal No. 23802 & 26712/CIC/2017 dated 31-10-2018.

The complainant stated that he was not satisfied with the reply of the Public Information Officer, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the Covid-19 pandemic, with a request to both the parties to attend for telephonic hearing on **04-06-2021 at 11.00 AM**.

In view of the Covid -19 Pandemic, the case is heard over phone on 04-06-2021 with prior intimation to the concerned parties. The complainant responded and stated that the PIO has furnished only part information. The PIO /Sri. Chandrasekhar, Deputy Tahsildar, Medchal Mandal, Medchal Malkajgiri District responded and stated that the information sought by the complainant is furnished but failed to provide the copy of the same.

Heard both the parties and perused the material papers available on record. The Commission observed that the Commission in the earlier Appeal No.23802 & 26712/CIC/2017, order dated.31-10-2018 has directed the PIO to furnish the information to the complainant for item No. 3 & 4 of the 6(1) application filed by the complainant but the PIO failed to produce any proof of furnishing the same before the Commission. Hence the Commission directs to issue **Show Cause Notice** to the PIO/ Sri. Chandrasekhar, Deputy Tahsildar, Medchal Mandal, Medchal Malkajgiri District for not following the directions issued by the Commission.

The Commission also directs the PIO to furnish the information to the complainant within one week through Registered post with acknowledgement due. The order on **Show**Cause Notice will be dealt separately.

With the above direction, the complaint is closed.
