Order

Sri G. Surarchita Reddy has filed complaint dated **30-04-2019** which was received by this Commission on **04-05-2019** for not getting the information sought by him from the Public Information Officer/ O/o the Telangana State Medical Council, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **18-03-2019** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

I, G. Surarchita Reddy, S/o Sri G. Janardhan Reddy, Complainant of the Case No : 07/2017, request you to kindly issue me the Certified copies of the following items mentioned below, for filing an Appeal in the High court & also in the Medical Council Of India and also for other Legal Purpose. I, request you to kindly put the official seal on all the pages.

- 1) Certified copies of all the Affidavit complaint, Rejoinders, Replies, Counters & Annexure's, filed by me in the above mentioned case.
- 2) Certified Copies of the Counter Affidavits, Replies, Written submissions filed by Dr. Vijay Dikshit & the Apollo Hospitals, Jubilee Hills, Hyderabad in the above mentioned Case.
- 3) Certified copies of the Recent Judgment TSMS/1043/ETHICS/CASE No.07/2017 Dated: 27.02.2019.
- 4) Certified Copy of my Request letter Dated : 20th Feb. 2019
- 5) Certified Copies of my Request letter Dated : 29th Jan.2019, along with certified copy of the enclosure attached.
- 6) Certified Copies of my Request letter, Dated : 17th April 2017 & 25th Oct. 2017.
- 7) Certified copies of all the proceedings & Cross Examination proceedings of the above case.

Stating that the complainant did not get any response from the Public Information Officer, he preferred this complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing on **07-04-2021 at 10.30 AM.**

The Case was heard on 07-04-2021. The complainant was absent. The PIO/ Dr.Ch.Hanmantha Rao, Registrar, Telangana State Medical Council, Hyderabad was present and submitted that vide letter TSMC/1043/Ethics/RTI/293/Case No.07/2017, dated.08-04-2019 the information sought by the complainant is furnished in their office with personal endorsement of the complainant. The PIO further submitted a copy of information before the Commission.

The Commission perused the material papers available on records and observed that the PIO has furnished the information to the Complainant.

Since the information is furnished, the complaint is closed.
