## **Order**

Sri G. Surarchita Reddy has filed second appeal dated **30-04-2019** which was received by this Commission on **04-05-2019** for not getting the information sought by him from the Public Information Officer/ O/o the Telangana State Medical Council, Hyderabad and the First Appellate Authority/ O/o the Telangana State Medical Council, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **12-12-2018** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

~~Kindly provide me the information under the following points:-~~

- 1) KINDLY PROVIDE ME THE CERTIFIED INFORMATION / ACTION TAKEN REPORT ON THE LETTERS ADDRESSED TO THE CHAIRMAN (TSMC) , DATED: 1) 17TH SEPT.2018 & 2) 22ND OCT.2018 , and their certified true Copies .
- 2) KINDLY PROVIDE ME THE CERTIFIED COPIES OF THE CROSS EXAMINATION PROCEEDINGS / RECORDINGS COPIES, WHICH ARE ATTENDED BY ME .
- 3) FURNISH ALL THE INTIMATION LETTERS WHICH ARE SENT BY THE TSMC, TO ME (G.Surarchita Reddy)DR.VIJAY DIKSHIT OF APOLLO HOSPITAL, & Dr.RAVINDRA BABU MEDICAL SUPERINTENDENT OF APOLLO HOSPITALS, & TO THE CONCERNED AUTHORITIES OF CARE HOSPITAL , NAMPALLY ,HYDERABAD.
- 4) KINDLY PROVIDE ME THE CERTIFIED INFORMATION OF THE NAMES & PHOTOGRAPHS OF THE ETHICS COMMITTEE MEMBERS WHO ARE DEALING WITH MY COMPLAINT CASE OF MY MOTHER HITHERTO ( G.SURARCHITA REDDY V/S DR.VIJAY DIKSHIT & APOLLO HOSPITAL, J.HILLS, HYD.
- 5) FURNISH ME THE CERTIFIED COPIES OF THE UNDERTAKING LETTERS GIVEN BY ME (G.SURARCHITA REDDY ) , DR.VIJAY DIKSHIT & DR.RAVINDRA BABU(MEDICAL SUPERINTENDENT OF APOLLO HOSPITAL), J.HILLS, HYD, , FOR NON-APPOINTMENT OF ADVOCATES ,ON EITHER SIDES ( BOTH THE PARTIES ARE WILLING TO ARGUE THEIR OWN CASE ) . to the Ethics Committee

The Public Information Officer through Lr.No. TSMC/1043/Ethics/Case No. 7/2017 dated 02-01-2019 furnished available information to the appellant.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1<sup>st</sup> appeal dated **06-01-2019** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing on **07-04-2021 at 10.30 AM.**

The Case was heard on 07-04-2021. The appellant was absent. The PIO/ Dr.Ch.Hanmantha Rao, Registrar, Telangana State Medical Council, Hyderabad was present and submitted that vide letter TSMC/1043/Ethics/Case No.07/2017, dated.02-01-2019 the information sought by the appellant has been furnished through registered post. The PIO further submitted a copy of the information before the Commission along with the copy of the postal receipt.

The Commission perused the material papers available on records and observed that the PIO has furnished the information to the appellant.

Since the information is furnished, the appeal is closed.
