## **Order**

Sri A. Raju has filed second appeal dated **02-05-2019** which was received by this Commission on **06-05-2019** for not getting the information sought by him from the Public Information Officer/ The GM (PER), RC, IR & PM, O/o the SCCL., Kothagudem, Bhadradri – Kothagudem District and the First Appellate Authority/ O/ o the GM (HRD), SCCL., Kothagudem, Bhadradri – Kothagudem District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **09-02-2019** before the Public Information Officer/C&MD., SCCL., Hyderabad requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

నేను అనగా అంకుస్ రాజు, తండ్రి: భీమయ్య, ఇంటి నెంబర్ : 8-88, దొంతపూర్, ధర్మపురి, జిల్లా: జగిత్యాల నివాసిని ఈ సింగరేణి సమస్య నందు అనారోగ్య కారణంగా కనీసం రెండేళ్లు మిగులు సర్వీస్ ఉండాలి అనే నిబంధనను ఎత్తివేస్తూ 58 సంవత్సరాలు దాటిన కార్మికులు ఎవ్వరైనా అనారోగ్య కారణంగా మెడికల్ బోర్డుకి అప్లై చేసుకోవచ్చు అని ఇటీవల హైకోర్టు జారీ చేసినట్లు వంటి ఉత్తర్వులు (ఆర్డర్స్) తాలూకు సంబంధించిన నకలు కాపీ ఒకటి సమాచార హక్కు చట్టం ద్వారా ఇప్పించ వలసిందిగా దరఖాస్తు చేసుకుంటున్నాను.

The Public Information Officer through Ref.No. CRP/RTI-PIO/2801/161 dated 13-02-2019 requested the GM (P) RC, IR & PM and CMO Main Hospital to furnish the information on priority as the information is sought under RTI Act, 2005 which is time bound, for onward submission to the applicant.

The Public Information Officer through Ref. No. CRP/RTI-PIO/2801/216 dated 01-03-2019 informed that the information sought by the applicant is not specific.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1<sup>st</sup> appeal dated **23-03-2019** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

The Public Information Officer through Ref.No. CRP/RTI-PIO/2801/342 dated 19-04-2019 informed that the information sought by the applicant comes under the purview of 3<sup>rd</sup> party information.

Stating that the appellant was not satisfied with the reply of the Public Information Officer and the First Appellate Authority, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing on **19-04-2021 at 10.30 AM.**

The Case was heard on 19-04-2021. The appellant was absent. The PIO/Sri.D.Srinivas, Deputy General Manager(Personnel), O/o.SCCL, Kothagudem, Bhadradi Kothagudem District was present and stated that vide letter Ref.No.CRP/RTI-PIO/2801/293, dated.12-07-2019 the information sought has been furnished to the appellant through registered post. The PIO further submitted a copy of the information along with the copy of the postal acknowledgement.

Heard the PIO and perused the material papers available on records. The Commission observed that PIO has furnished the available information to the appellant.

Since the information is furnished, the appeal is closed.
