<u>Order</u>

Sri Avinash has filed second appeal dated **25-05-2018** which was received by this Commission on **25-05-2019** for not getting the information sought by him from the Public Information Officer/ O/o the Government Maternity Hospital, Hyderabad and the First Appellate Authority/ O/o the Director of Medical Education, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **23-02-2018** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

- 1) Please furnish complete <u>CERTIFIED ATTESTED</u> copies of (i) FIR. (ii) Charge Memo (if any). (iii) Correspondence / Communication received from concerned Police Authorities. (iv) Suspension Copy. (v) Disciplinary case details etc, in respect of Sri. Mohammed Sujathullah, Junior Assistant, MRD Section, Government Maternity Hospital, Koti, Hyderabad, as appeared in Sakshi Telugu Newspaper item on <u>Dated: 03/02/2019</u>. A copy of aforesaid Newspaper clipping is enclosed for perusal.
- 2) Please furnish complete <u>CERTIFIED / ATTESTED</u> copies of Day to Day progress, Present Stage and Action Taken Report in respect of my <u>Complaint</u>, <u>Dated: 11/02/2019</u> submitted to Director of Medical Education, Government of Telangana, Koti, Hyderabad and a copy submitted to Director of Public Health & Family Welfare, Government of Telangana, Koti, Hyderabad against Telephone Operator of Gandhi Hospital, Secunderabad. A copy of aforesaid complaint enclosed.
- 3) Please furnish complete <u>CERTIFIED / ATTESTED</u> copies of correspondence / communication received (if any) from O/o Director of Public Health & Family Welfare, Government of Telangana, Koti, Hyderabad to Director of Medical Education, Government of Telangana, Koti, Hyderabad in respect of my <u>Complaint</u>, <u>Dated: 11/02/2019</u> stated above. A copy of aforesaid complaint enclosed.
- 4) Please furnish complete <u>CERTIFIED / ATTESTED</u> copies of Day to Day progress, Present Stage and Action Taken Report in respect of my <u>Email Complaint</u>, <u>Dated</u>: <u>11/02/2019</u> sent to <u>dmetelangana@gmail.com</u> and <u>complaindme@gmail.com</u> against Telephone Operator of Gandhi Hospital, Secunderabad. A copy of aforesaid Email correspondence is enclosed for kind perusal.

More (6) points.

The Public Information Officer through Lr.Rc.No. 3831/RTISDEH/2018 dated 03-12-2018 furnished available information to the appellant.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1st appeal dated **28-03-2019** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

The First Appellate Authority through Lr.rc.No. 8853/RTI/VC3/2019 dated 29-03-2019 transferred the application dated 23-02-2018 to the Public Information Officer/Govt. Maternity Hospital, Hyderabad and the Public Information Officer/Gandhi Hospital, Hyderabad with a request to provide the point wise information to the applicant.

The Public Information Officer/ Govt. Maternity Hospital, Hyderabad through Lr.Rc.No. 80/RTI/E3/GMH/SBh/2019 dated 22-04-2019 furnished available information to the appellant.

available information to the appenant.

Stating that the appellant was not satisfied with the reply of the First Appellate Authority, he preferred this 2^{nd} appeal before this Commission requesting

to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing

on 20-04-2019 at 10.30 AM.

The Case was heard on 20-04-2021. The appellant was absent. The PIO/Dr.K.Rajya Lakshmi, Superintendent, O/o.the Government Maternity

Hospital, Koti, Hyderabad was present and stated before the Commission that the

information sought by the appellant is furnished and the appellant also vide his

mail dated.25-03-2021 submitted that he is intending to withdraw his appeal. The FAA/Sri.N.Sivaiah, Administrative Officer, O/o. Director of Medical Education,

Hyderabad was present and stated that they have forwarded the application to the

concerned PIO's to furnish the information directly to the appellant.

The Commission perused the material papers available on records and observed that the appellant through his mail dated.25-03-2021 has requested the

Commission to permit him to withdraw the appeal. Hence, the appeal is closed.
