## Order

Sri S. Chandrasekhar has filed second appeal dated **24-05-2019** which was received by this Commission on **27-05-2019** for not getting the information sought by him from the Public Information Officer/ O/o the Telangana State Medical Council, Hyderabad and the First Appellate Authority/ O/o the Telangana State Medical Council, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **10-12-2018** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

- 1. You are requested to give a copy of the press release issued by TSMC on 6th June 2018, pertaining to the action taken against five doctors.**
- 2. You are requested to give the list of doctors with their names and qualifications, whose registrations have been suspended by the TSMC since 1st January 2015 till date. You are also requested to give a copy of all suspension orders issued for the same.**
- 3. You are also requested to give the minutes of all ethics committee meetings conducted by TSMC since 1st Jan 2015 till date.**
- 4. You are also requested to give the procedure followed by the TSMC in conducting an inquiry into complaint against a doctor. Kindly specify the procedure followed since 1st Jan 2015 and any changes in the procedure since then.**
- 5. You are also requested to give details of your election procedure for constitution of the TSMC, last conducted elections and details of nominated and elected members.**

The Public Information Officer through Lr.No. TSMC/1346/RTI/2018 dated 07-01-2019 furnished available information to the appellant.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1<sup>st</sup> appeal dated **15-02-2019** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing on **07-04-2021 at 10.30 AM.**

The Case was heard on 07-04-2021. The representative of the appellant Sri.J.Kakar was present and through affidavit submitted that the PIO has furnished only part information. The PIO/ Dr.Ch.Hanmantha Rao, Registrar, Telangana State Medical Council, Hyderabad was present and submitted that vide letter TSMC/1346/RTI/2018, dated.07-01-2019, vide letter TSMC/1346/176/RTI/2018, dated.28-05-2019 and also vide letter TSMC/1136/RTI/2019, dated.14-11-2019 the information sought by the appellant has been furnished through registered post. The PIO further submitted a copy of the information before the Commission along with the copy of the postal receipt.

Heard both the parties and perused the material papers available on records. The Commission observed that the PIO has furnished only part information to the appellant and the appellant also claims that he has received only information for point No.1 out of 5 points sought by him in his 6(1) application dated.10-12-2018.

Hence the Commission directs the PIO to furnish the information for remaining points to the appellant within one week through registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appellant is closed.
