Order

Sri G. Krishna filed complaint dated **01-06-2019** which was received by this Commission on **03-06-2019** stating that the Public Information Officer/ O/o the Deputy Commissioner, GHMC., Circle-22, Patancheru & Ramachandrapuram, Sangareddy District did not implement the Commission Order in Appeal No. 6213/SIC/2018 dated 15-04-2019.

The complainant stated that he was not satisfied with the reply of the Public Information Officer, he preferred these Complaints before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

The Public Information Officer through Lr.No.39/TPS/Cir-22/SLPZ/GHMC/2019 dated 17-01-2020 informed to the Commission that the available information has furnished to the complainant on 06-01-2020.

In view of the above, with a request to both the parties to attend for hearing on **26-04-2021 at 10.30 AM**.

The Case was heard on 26-04-2021. The complainant was absent. The PIO/Sri.L.Swamy Nayak, Asst. City Planner, GHMC, Circle – 22, Patancheru, Sangareddy District was present and stated that vide letter.No.RTI/116/PTC & RCP/Cir-22/WZ/GHMC/2017, dated.12-01-2017 part information was already furnished to the appellant and also vide letter.No.RTI/39/PTC & RCP/Cir-22/SLPZ/GHMC/2019, dated.06-01-2020 the available information was furnished to the complainant. The PIO further submitted a copy of the information before the Commission along with the copy of the postal receipt as a proof of dispatch.

The Commission perused the material papers available on records and observed that the PIO has agreed that he has furnished the available information but the Commission observed that the PIO has not provided the permission copy sought by the complainant.
