Order

Dr. Najeebuddin has filed second appeal dated **03-07-2019** which was received by this Commission on **03-07-2019** for not getting the information sought by him from the Public Information Officer/ O/o the AYUSH, Hyderabad and the First Appellate Authority/ O/o the AYUSH, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **13-03-2019** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

- 1) **What is the prescribed time limit for processing License renewal application?**
- 2) **What is the status of license renewal application of Bharat unan pharmacy- license no 522/U/13. Applied on 01-01-2018**

Stating that the appellant did not get any response from the Public Information Officer, he filed 1st appeal dated **09-05-2019** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing on **06-04-2021 at 10.30 AM.**

The Case was heard on 06-04-2021. The appellant was absent. The PIO/Dr.Mohd. Shafeq Ahmed, Durg Inspector, O/o. the AYUSH(UNANI) Abids, Hyderabad was present and requested the Commission that the information sought by the appellant is brought before the Commission and will provide the same to appellant within 2 days. The PIO further submitted a copy of the information before the Commission.

The Commission took a serious view against the PIO for not furnishing the information to the appellant within the stipulated period of 30 days as per section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

The Commission directs the PIO to furnish the information to the appellant within one week through registered post with acknowledgment due and to report compliance to the Commission.

With the above direction, the appeal is closed.
