## **Order**

Dr. K. Prakash has filed complaint dated **11-07-2019** which was received by this Commission on **11-07-2019** for not getting the information sought by him from the Public Information Officer/ O/o the Aarogyasri Incharge & Incentives Distribution, MNJ Institute of Oncology & Regional Cancer Centre, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **02-05-2019** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

*I, Dr K Prakash, Professor of Radiotherapy, bring to your notice that despite my representation and discussion regarding the distribution of aarogyasri amount for period of April 2018 to September 2018, no information has been given till date, despite having issues regarding distribution of this huge amount of nearly Rs.38,00,000(Thirty eight lakhs).*

*Keeping in view of the above for not responding to my discussion, I am herewith enclosing a Postal order number:46F 095098, dated:02/05/2019, for Rs.10/- drawn in your favor for obtaining information and following copies under RTI.*

- 1. Copy of Rules, regulations and guidelines followed for distribution of aarogyasri amount for period of April 2018, to September 2018.*
- 2. Copies of leave letters forwarded, sanction orders and joining report of Dr Raghuraman, Associate professor, Gandhi hospital, Hyderabad, for period of April 2018 to September 2018.*
- 3. Copies of aarogyasri distribution list and amount of white unit and details of distribution for April 2018 to September 2018.*

The Public Information Officer through Lr.No. E4/MNJ IO & RCC/2019 dated 28-06-2019 furnished available information to the complainant.

Stating that the complainant was not satisfied with the reply of the Public Information Officer, he preferred this complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

The Public Information Officer through Lr.No. E4/MNJ IO & RCC/2019/178 dated 20-08-2019 informed to the Commission that the sought information is already furnished to the complainant through Letter dated 28-06-2019, a copy of dispatch proof is also enclosed.

In view of the above, with a request to both the parties to attend for hearing on **20-04-2021 at 10.30 AM.**

The Case was heard on 20-04-2021. The complainant was absent. The PIO/Sri.A.Sudhakar, Office Superintendent, O/o. the MNJ Institute of Oncology & Regional Cancer Centre, Hyderabad was present and stated before the Commission that vide letter No.E4/MNJIO&RCC/2019/108, dated.28-06-2019 the information sought by the complainant is furnished through registered post. The PIO further submitted a copy of the information along with the copy of the postal receipt.

The Commission perused the material papers available on records and observed that the PIO has furnished the information to the complainant.

Since the information is furnished, the complainant is closed.
