Order

Smt M. Padmavathi has filed complaint dated **10-07-2019** which was received by this Commission on **12-07-2019** for not getting the information sought by him from the Public Information Officer/ O/o the SCCL., Kothagudem, Bhadradi – Kothagudem District.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **11-02-2019** before the Public Information Officer/ O/o the Secretary, Ministry of Coal, New Delhi requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

- ① The admission and status report on my Regd. letter dated 13.1.2019 to your office.
- ② The procedure, NCWA and Singareni Collieries Ltd. Kothagudem, T.S. Agreements, implementation circulars copies to be sent to me as on 25.2.2000 on confirmation of Date of Birth certificate issued by Government Municipal High School, Tenali. The then archives A.D. Trade Admn. 5689, Study certificate IX date 27.4.2005.
- ③ As per Company Medical Board on 25.2.2000 age was fixed 39 years. As per Govt. School, T. Dada TC. Date of Birth is recorded, issued DOB is 10.8.1962. The correct and confirmation of DOB is 10.8.1962 is valid and not in form clearly enclosed concerned documents.
Le. As a wife of Late Sri M.V. Raju an employee of Singareni Collieries Ltd. eligible to get Monthly Monetary Compensation upto 60% of 10 open years. The MMC is to be paid upto 25.2.2022. Valid medical board of Sing. As per Study certificate 2000 eligible upto 10.8.2022. Based on Act, Rules & Regs. My MMC eligible date is 10.8.2022 and in form.

The CPIO (PCA), New Delhi through Letter dated 07-03-2019 transferred the application under section 6(3) of RTI Act, 2005 to the Public Information Officer/ SCCL and requested to kindly send the information directly to the complainant.

Stating that the complainant was not satisfied with the reply of the Public Information Officer, she preferred this complaint before the Commission requesting to arrange to furnish the information sought by her u/s 18(1) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing on **19-04-2021 at 10.30 AM.**

The Case was heard on 19-04-2021. Sri.Sambasivaw Raav, representative of the complainant was present and submitted that the PIO has not provided any information. The PIO/ Sri.D.Srinivas, Deputy General Manager(Personnel), O/o.SCCL, Kothagudem, Bhadradi Kothagudem District was present and submitted a letter Ref.No.CRP/RTI-PIO/G.C.-C.I.C/337, dated.13-03-2021 stating that the 6(1) filed by the complainant was transferred from the Ministry of Coal, Govt. of India to the Appellate Authority and so they have not received the application.

The Commission directs the PIO to furnish the information to the complainant within one week through Registered post with acknowledgment due and to report compliance to the Commission.

With the above direction, the complaint is closed.
