## **Order**

Smt. T. Geetanjali has filed second appeal dated **19-07-2019** which received by this Commission on **19-07-2019** for not getting the information sought by him from the Public Information Officer/ O/o the Deputy Commissioner, GHMC., Circle-20, Serilingampally, Ranga Reddy District and the First Appellate Authority/ O/o the Zonal Commissioner, Serilingampally Zone, Ranga Reddy District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **09-11-2018** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

1. LRS Application submitted by Smt.T.Geetanjali vide File No.2749/Cir 11/WZ/2013, dated 31.05.2013.
2. DD No.372030, dated 31.05.2013 for amount of Rs.10,000/- drawn on Corporation Bank, Tarnaka branch, Sec'bad, paid in favour of The Commissioner, GHMC.
3. All communications addressed to the LRS applicant till date.
4. Proceedings if any passed in respect of above said LRS application.

Stating that the appellant did not get any response from the Public Information Officer, she filed 1<sup>st</sup> appeal dated **18-02-2019** before the First Appellate Authority requesting him to furnish the information sought by her u/s 19(1) of the RTI Act, 2005.

The First Appellate Authority through Order dated 16-04-2019 directed the Public Information Officer to furnish full/ complete information to the appellant within ten days and closed the appeal.

Stating that the appellant was not satisfied with the reply of the First Appellate Authority, she preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by her u/s 19(3) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing on **26-04-2021 at 10.30 AM.**

The case was heard on 26-04-2021. The appellant and the Public Information Officer both are absent. Hence, the case is **adjourned.**

In view of the Covid-19 pandemic, with a request to both the parties to attend for telephonic hearing on **23-06-2021 at 11.00 AM.**

In view of the Covid -19 Pandemic, the case is heard over phone on 23-06-2021 with prior intimation to the concerned parties. The appellant responded and stated that the PIO has not furnished any information regarding LRS document sought by him in his 6(1) application. The PIO / Sri.Narsimha Ramulu, City Planner, Serilingampally Zone responded and stated that vide letter No.1165/RTI/CP/SLPZ/GHMC/2021, dated.21-06-2021 they informed the appellant that they were unable to trace out the information sought by the appellant.

Heard both the parties and perused the material papers available on record. The Commission observed the Commission did not accept the plea made by the PIO and thereby directs the PIO to furnish the held information to the appellant within one week through RPAD and to report compliance to the Commission. If the PIO fails to comply with the instructions issued, action will be taken against the PIO as per section 20 of the RTI Act, 2005.

With the above direction, the appeal is closed.
