

## Order

Sri M. Rajaiah has filed second appeal dated **24-07-2019** which was received by this Commission on **25-07-2019** for not getting the information sought by him from the Public Information Officer/ The GM (PER), O/o the SCCL., Kothagudem, Bhadradri – Kothagudem District and the First Appellate Authority/ O/ o the GM (HRD), SCCL., Kothagudem, Bhadradri – Kothagudem District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **09-03-2019** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:



The Public Information Officer through Ref.No. CRP/RTI-PIO/2817/263

dated 19-03-2019 requested the GM (PER) Welfare & CSR to furnish the

information to the applicant.

Stating that the appellant was not satisfied with the reply of the Public

Information Officer, he filed 1st appeal dated **20-05-2019** before the First Appellate

Authority requesting him to furnish the information sought by him u/s 19(1) of the

RTI Act, 2005.

The First Appellate Authority through Letter dated 29-05-2019 requested the

Public Information Officer, Corporate & Hyderabad Areas to furnish the available

information to the appellant.

Stating that the appellant was not satisfied with the reply of the Public

Information Officer and the First Appellate Authority, he preferred this 2<sup>nd</sup> appeal

before this Commission requesting to arrange to furnish the information sought by

him u/s 19(3) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing

on 19-04-2021 at 10.30 AM.

The Case was heard on 19-04-2021. The appellant was present and stated

that the PIO has not furnished the any information till date. The PIO/

Sri.D.Srinivas, Deputy General Manager (Personnel), O/o.SCCL, Kothagudem,

Bhadradri Kothagudem District was present and stated that a letter

Ref.No.CRP/RTI-PIO/2817/462, dated.15-04-2021 has been forwarded to the

appellant stating that the information sought by him is very voluminous and

required much time to dispense it off completely and requested the appellant to

visit their office in person to receive the information pertaining to their office.

Heard both the parties and perused the material papers available on records.

The Commission observed that the appellant has claimed that he requires only the

CMPF amount pertaining to ex-employees but the PIO is stating that it is

voluminous information. The Commission did not accept the Contention of PIO and

thereby warns the PIO not to repeat the same in the future.

The Commission directs the PIO to furnish the information to the appellant

within one week through registered post with acknowledgment due and to report

compliance to the Commission.

With the above direction, the appeal is closed.
