Order

Sri K. Prabhakar has filed second appeal dated **24-07-2019** which was received by this Commission on **30-07-2019** for not getting the information sought by him from the Public Information Officer/ O/o the Deputy Commissioner, GHMC., Circle-20, Serilingampally, Ranga Reddy District and the First Appellate Authority/ O/o the Zonal Commissioner, Serilingampally Zone, Ranga Reddy District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **23-02-2019** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

1. Certified copies of the **Action Taken Reports (ATRs)** and the correspondence between the Applicant and the Deputy Commissioner, Circle-20, GHMC, Serilingampally regarding the Development of parks in Sai Aishwarya Residency, Khajaguda . The copies of the said Ref is enclosed herewith.
2. A certified copy of the name(s), designation(s) and office address(es) of the official(s) who had failed to take necessary actions relating to the said Ref and the charge sheet(s) issued to such indolent official(s).

Stating that the appellant did not get any response from the Public Information Officer, he filed 1st appeal dated **13-04-2019** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

The First Appellate Authority through Notice dated 04-05-2019 directed the Public Information Officer and the appellant to appear for hearing on 13-05-2019 @ 3.00 PM along with related records/ documents.

The First Appellate Authority through Order dated 14-05-2019 advised the applicant to file a fresh application to the Dy. Commissioner, Cir.20, GHMC for laying the roads and Drainage and closed the appeal.

Stating that the appellant was not satisfied with the reply of the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing on **26-04-2021 at 10.30 AM.**

The Case was heard on 26-04-2021. The appellant was absent. The PIO/ Sri.Mohd, Yousuf Pasha, Manager, USB, GHMC, Circle-20, Serilingampally Zone was present and stated before the Commission that vide letter dated.16-04-2019 the information sought by the appellant has been furnished to the appellant. The PIO further submitted a copy of the information before the Commission.

Heard the PIO and perused the material papers available on record. The Commission observed that though the PIO has agreed that he has furnished the information but failed to file the copy of the postal receipt as a proof of dispatch.

Therefore the Commission directs the PIO to furnish the information once again to the appellant within one week through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
