Order

Sri K. Prabhakar has filed second appeal dated **24-07-2019** which was received by this Commission on **30-07-2019** for not getting the information sought by him from the Public Information Officer/ O/o the Deputy Commissioner, GHMC., Circle-20, Serilingampally, Ranga Reddy District and the First Appellate Authority/ O/o the Zonal Commissioner, Serilingampally Zone, Ranga Reddy District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **25-02-2019** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

- 1. Certified copies of the Action Taken Reports (ATRs) and the correspondence between the Applicant and the Deputy Commissioner, Circle-20, GHMC, Serilingampally regarding the Diversion of nala from Sai Aishwarya colony to Lanco hills road / Delhi public school lane, Khajaguda, dated 22-10-2018, & 07-01-2019. The copies of the said Ref is enclosed herewith.
- 2. A certified copy of the name(s), designation(s) and office address(es) of the official(s) who had failed to take necessary actions relating to the said Ref and the charge sheet(s) issued to such indolent official(s).

Postal Order of the value of Rs.10/- is sent herewith towards the Application Fee, in compliance with the <u>Right to Information (Regulation of Fees and Cost) Rules, 2005</u>.

Stating that the appellant did not get any response from the Public Information Officer, he filed 1st appeal dated **13-04-2019** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

The First Appellate Authority through Notice dated 04-05-2019 directed the Public Information Officer and the appellant to appear for hearing on 13-05-2019 @ 3.00 PM along with related records/ documents.

The First Appellate Authority through Order dated 14-05-2019 directed the Public Information Officer to furnish full/ complete information within ten days to

the appellant and closed the appeal.

Stating that the appellant was not satisfied with the reply of the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting

to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing

on 26-04-2021 at 10.30 AM.

The Case was heard on 26-04-2021. The appellant was absent. The

PIO/Smt.G.Krishnaveni, Assistant Engineer, O/o.the Deputy Commissioner,

GHMC, Circle-20. Serilingampally Zone was present and stated that vide letter

Lr.No.ENG/CIR-20/SLPZ/GHMC/2021-22/116, dated.18-04-2021 the information

sought by the appellant has been furnished through registered post. The PIO

further submitted a copy of the information along with the copy of the postal

receipt as a proof of dispatch.

Heard the PIO and perused the material papers available on records. The

Commission observed that PIO has furnished the information to the appellant.

Since the information is furnished, the appeal is closed.
