
Complainant : Ms. N. Nagalakshmi, D/o. Late N. Jangaiah, H.No. 18-9-30/15/1/C, Chandrayangutta, Hyderabad.

Respondent : Public Information Officer (U/RTI Act, 2005) O/o the Director of Medical Education, Hyderabad.

Order

Ms. N. Nagalakshmi has filed complaint which was received by this Commission on **31-07-2019** for not getting the information sought by him from the Public Information Officer/ O/o the Director of Medical Education, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed an application dated **10-06-2019** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:



The undersigned ~~Mr. Nagina Nagalakshmi~~ D/o late. N. Jangaiah submit that the file pertaining to the subject cited a copy of it may be made available to me and also the endorsement file transmitted to you by the Comptroller's letter containing her remarks.

③ Collector Hyderabad District circular instructions issued in Lr.No. C.N.Suz/In (H.P)/12 dated 18.6.2012

③ My file No. 20582 dated 20/6/2012 which is required by me for further action by me in the matter.

My father was Mr. N. Chale working orderly irregularly appointed Mrs. N. Sankhya Devi w/o late. Srinivas. changed the Lr.No. and file No. I am affixing a stamp worth Rs 10/- enabling you to comply with my request.

Stating that the complainant did not get any response from the Public Information Officer, she preferred this complaint before the Commission requesting to arrange to furnish the information sought by her u/s 18(1) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing on **07-04-2021 at 10.30 AM.**

The Public Information Officer through Lr.Rc.No. 24074/RTI/2019 dated 27-08-2019 informed to the Commission that required information has been already submitted to the complainant vide their office Lr.Rc.No. 24074/G2/RTI/19 dated 09-07-2019 through speed post and the same is returned by the postal authority due to reason the individual is refused on 13-07-2019 (copy enclosed).

The Case was heard on 07-04-2021. The complainant was absent. The APIO/ Sri.T.J.David, Office Superintendent, O/o. the Director of Medical Education, Koti, Hyderabad was present and stated that a letter Rc.No.24074/G2/RTI/2019, dated.01-07-2018 has been forwarded to the complainant through registered post stating that the information sought by him is not available in their office. The PIO further stated they even called the appellant to their office and submitted a letter Lr.Rc.No. 24074/G2/RTI/2019, dated. 03-07-2019 stating the non availability of records but the complainant refused to accept the same.

Heard the PIO and perused the material papers available on records. The Commission cannot accept the plea made by the APIO and directs the PIO to make a thorough search and arrange to furnish the information sought by the appellant through his 6(1) application dated.10-06-2019. The Commission directs the to furnish the information to the complainant within 15 days through registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
