Order

Sri A. Srinivas has filed second appeal dated **19-08-2019** which was received by this Commission on **19-08-2019** for not getting the information sought by him from the Public Information Officer/ O/o the MNJ Institute of Oncology & Regional Cancer Centre, Hyderabad and the First Appellate Authority/ O/o the MNJ Institute of Oncology & Regional Cancer Centre, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **15-05-2019** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

1. ఆరోగ్యశ్రీ స్పీమ్ క్రింద ఎం.ఎన్.జె. క్యాన్సర్ హాస్పిటల్ కు 2014-15 సంవత్సరం నుండి 2018-19 వరకు వచ్చిన ఆదాయం ఎంత? సంవత్సరం వారీగా వివరాలు తెలపండి.
2. ఆరోగ్యశ్రీ స్పీమ్ ద్వారా వచ్చిన ఆదాయంలో 70% హాస్పిటల్ అభివృద్ధికి ఖర్చు చేయాలనే నిబంధన అమలు చేస్తున్నారా? హాస్పిటల్ అభివృద్ధికి ఖర్చు చేసి ఉంటే ఏ ఏ పనులకు ఎంత ఖర్చు చేశారు? 2014-15 నుండి 2018-19 వరకు జరిగిన అభివృద్ధి పనులు, ఖర్చుల వివరాలు తెలపండి.
3. ఆరోగ్యశ్రీ స్పీమ్ లో వైద్య చికిత్స చేయించుకునే రోగుల నుండి వివిధ పరీక్షల కోసం చార్జీలు వసూలు చేస్తున్నారా? గత ఐదేళ్ళలో ఎంత మంది రోగుల నుండి ఎంత మొత్తం వసూలు చేశారు? ఆరోగ్యశ్రీ నుండి రీయింబర్స్ మెంట్ అయిన తర్వాత ఎంత మంది రోగులకు ఎంత మొత్తం చెల్లించారు? పూర్తి వివరాలు తెలపండి.

Stating that the appellant did not get any response from the Public Information Officer, he filed 1st appeal dated **20-06-2019** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing on **20-04-2019 at 10.30 AM.**

The Case was heard on 20-04-2021. The appellant was present and submitted that the PIO has not furnished any information. The PIO/Sri.A.Sudhakar, Office Superintendent, O/o. the MNJ Institute of Oncology & Regional Cancer Centre, Hyderabad was present and stated before the Commission that Dr.P.Srinivas, Civil Assistant Surgeon, has not furnished the information to the appellant.

Heard the PIO and perused the material papers available on records. The Commission observed that the PIO has not furnished the information to the appellant and thereby directs to issue **Show Cause Notice** to the Dr.P.Srinivas, Civil Assistant Surgeon for not furnishing the information to the appellant.

The Commission also directs the PIO to furnish the information to the appellant within one week through Registered post with acknowledgement due and to report compliance to the Commission. The order on **Show Cause Notice** will be dealt separately.

In view of the above, the appeal is closed.
