Order

Sri S. Suresh has filed second appeal dated **17-08-2019** which was received by this Commission on **22-08-2019** for not getting the information sought by him from the Public Information Officer/ O/o the Director of Medical Education, Hyderabad and the First Appellate Authority/ O/o the Director of Medical Education, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **28-05-2018** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

The Public Information Officer through Lr.Rc.No. 41215/VC3/RTI/2018 dated 14-12-2018 furnished available information to the appellant.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1st appeal dated **06-07-2019** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

The Public Information Officer through Lr.Rc.No. 22404/RTI/19 dated

09-07-2019 informed to the appellant that there is no information available in their

office as per the records verified.

Stating that the appellant was not satisfied with the reply of the First

Appellate Authority, he preferred this 2nd appeal before this Commission requesting

to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, with a request to both the parties to attend for hearing

on 07-04-2021 at 10.30 AM.

The Case was heard on 07-04-2021. The complainant was absent. The

APIO/ Sri.T.J.David, Office Superintendent, O/o. the Director of Medical

Education, Koti, Hyderabad was present and stated that a

Rc.No.22404/RTI/2019, dated.09-07-2019 has been forwarded to the appellant

through registered post stating that the information sought by him pertains to the

period before the bifurcation of the state and so the same is not available in their

office. The PIO further stated before the Commission that the appellant can seek

the same information by filing a separate 6(1) application from the AP state.

Heard the PIO and perused the material papers available on records. The

Commission observed that the appellant is seeking information about the records

before bifurcation of the Telangana state and so was unable to furnish to the

appellant. Hence the Commission advises the appellant to file a separate 6(1)

application before the concerned PIO of the AP state and seek the information.

With the above direction, the appeal is closed.
