Order

Sri S. Bhanu Shankar Rao filed a complaint dated **26-08-2019** which was received by this Commission on **26-08-2019** stating that the Public Information Officer/ Deputy Tahsildar, Ghatkesar Mandal, Medchal – Malkajgiri District did not implement the Commission Order in Appeal No. 8219/CIC/2018 dated 23-04-2019.

The complainant stated that he was not satisfied with the reply of the Public Information Officer, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the Covid-19 pandemic, with a request to both the parties to attend for telephonic hearing on <u>08-06-2021 at 11.00 AM.</u> The complainant responded and stated that the PIO has not furnished the information. The PIO /Sri. Ashwin, Deputy Tahsildar, Ghatkesar Mandal, Medchal Malkajgiri District responded and submitted a letter Lr.No.C/RTI/15-88/2021, dated.07-05-2021 stating that the information sought by the complainant pertains to Deval Balaji Temple of Gatkesar Mandal and the same has been transferred to the PIO O/o. the Assistant Commissioner, Endowment Department, Rangareddy District U/s.6(3) of the RTI Act, 2005.

Heard both the parties and perused the material papers available on record. The Commission took a series view for the delay caused in furnishing the information to the complainant. The Commission warns the PIO tobe careful in future and strictly adhere to the provisions of section 7(1) of the Act in furnishing the information within 30 days from the date of filing 6(1) application.

The Commission directs the PIO to collect the information from the PIO/ O/o. the Assistant Commissioner, Endowment Department, Rangareddy District and furnish the same to the complainant within two weeks through RPAD and report compliance to the commission. The PIO/ O/o. the Assistant Commissioner, Endowment Department, Rangareddy District is also directed to furnish the information within one week from the date of receipt of this order to the PIO/ Deputy Tahsildar, Ghatkesar Mandal, Medchal Malkajgiri District.

With the above direction, the complaint is closed.
