## **Order**

Sri GVVA Prasannam has filed complaint dated **17-08-2021** which was received by this Commission on **18-08-2021** for not getting the information sought by him from the Public Information Officer/ O/o the Mandal Primary Health Centre, Dundigal Quthbullapur Mandal, Medchal – Malkajgiri District.

The brief facts of the case as per the Complaint and other records received along with it are that the complainant herein filed application dated **18-03-2019** before the Public Information Officer requesting to furnish the information under Sec.6(1) of the RTI Act, 2005 on the following points mentioned:

- ❖ Furnish the certified Copy of Settlement Copy of JDR No.6 namely Smt.Goda Bheema Bai, D/o.G.Ananda Prasad Babu, in EP No.55/2017 in OS 1015/2008 on the file of fffAddl. Jr. Civil Judge at Miyapur.

Stating that the complainant did not get any response from the Public Information Officer, he preferred the complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **22-03-2022 at 10.30 AM**

The case is heard on 22-03-2022. The complainant is absent. The PIO/O/o. the Mandal Primary Health Centre, Dundigal, Medchal Malkajgiri District is also absent.

The Commission perused the material papers available on record and observed that the PIO has not furnished the information and was also absent for hearing even after the receipt of notice from the Commission. The Commission took a serious view against the PIO and directs to issue **Show Cause Notice** to the PIO for not furnishing the information to the complainant and also for his absence before the Commission.

The Commission also directs the PIO to furnish the information to the complainant within one week from the date of receipt of this order through RPAD and to report compliance to the Commission. The action on **Show Cause Notice** will be dealt separately.

With the above direction, the complaint is closed.
