## **Order**

Ms. T. Suseelamma has filed second appeal dated **09-12-2020** which was received by this Commission on **09-12-2020** for not getting the information sought by him from the Public Information Officer/ O/o the HM&FW Department, T.S. Secretariat, Hyderabad and the First Appellate Authority/ O/o the HM&FW Department, T.S. Secretariat, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **17-12-2019** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

*✓* while being acknowledged your above cited letter on 8-11-2019, thereby insistingly intimating me that my said appeal is under examination, you are, therefore extolled to kindly disclose me the "Action Taken Report" against the submission of my said revision petition and No pending charges pursuant to its para-wise and point-wise information within stipulated time and have your compliance.

Stating that the appellant did not get any response from the Public Information Officer, she filed 1<sup>st</sup> appeal dated **23-07-2020** before the First Appellate Authority requesting him to furnish the information sought by her u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, she preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by her u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **15-03-2022 at 10.30 AM.**

The Case is heard on 15-03-2022. The appellant is absent. The APIO/Sri M.Surender Reddy, Assistant Secretary to Government, Health Medical & Family Welfare Department, TS Secretariat, Hyderabad is present and stated that vide letter No.11318/VC.2/2021-1, dated.10-01-2022 the available information was furnished to the appellant. The APIO also filed a copy of the letter along with the copy of the postal acknowledgement.

Heard the APIO and perused the material papers available on record. The Commission observed that the PIO has furnished the available information to the appellant.

Since the information is furnished, the appeal is closed.
