## Order

Sri M. Sreedhar has filed second appeal dated **24-08-2021** which was received by this Commission on **25-08-2021** for not getting the information sought by him from the Public Information Officer/ O/o the DM&HO., Sangareddy District and the First Appellate Authority/ O/o the TVVP., Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **15-05-2021** before the Public Information Officer requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005 on the following points mentioned:

The Public Information Officer through Letter dated 07-06-2021 furnished available information to the appellant.

Stating that the appellant was not satisfied with the reply of the Public Information Officer, he filed 1<sup>st</sup> appeal dated **08-07-2021** before the First Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get any response from the First Appellate Authority, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, notice is issued to both the parties to attend for hearing on **22-03-2022 at 10.30 AM.**

The Case is heard on 22-03-2022. The appellant is absent. The PIO/Smt.D.Vijaya Shanthi, Administrative Officer, O/o the DM & HO, Sangareddy District is present and stated that vide letter No.818/RTI-A/2021, dated. 20-05-2021 the 6(1) application was transferred to the PIO/O/o the Medical Superintendent, District Hospital Sangareddy District to furnish the information directly to the appellant.

The PIO/ Dr.V.Bhagya Shekar Goud, C.S.S, A.O.A.F.O, O/o the District Hospital(TSVVP), Sangareddy District is present and stated that the information sought by the appellant was furnished vide LR.No.42/RTI/Supdt/DHH/SRD/2021, dated.30-06-221 through registered post. The PIO further filed a copy of the information along with the postal receipt as a proof of dispatch.

Heard the PIO's and perused the material papers available on record. The Commission observed that the PIO has furnished the information to the appellant.

Since the information is furnished, the appeal is closed.
